TERROR STRIKES

I was alerted into an analysis of why we're fought by comments from an organization executive.

An analysis shows there may have been many reasons but a further look makes them invalid.

A piercing scream against Dianetics arose before the first book was published in 1950. Press was hot against it before the first foundation was formed.

For seven months before there was any personal or personal troubles publicized, the bulk of articles against Dianetics had already appeared. At one time three national magazines were simultaneously on the stands screaming in lead articles about Dianetics and myself - and this was five months before any "divorce" publicity. And amongst the hundreds of reporters and commentators who screamed only one ever talked to me, and, from various evidences, none had read the book or knew anything about the subject.

Until May, 1950 I received only favorable publicity - on expeditions or comings or goings. In May 1950 there was a concerted shriek from people who (a) had not read the books and (b) who knew nothing bad about me.

These howls came from both conservative and liberal groups alike - the AMA - The Commies, The Socialists, the Roman Catholics.

Thus we can rule the following facts out of all the protests and "bad publicity" of the past eleven years:

1. That it stems from any knowledge of the subject;
2. That it is a concerted effort by any one group; and
3. That it is based on any knowledge of myself.

Now if we look further we also find these facts:

4. In the past eleven years, some thousands of texts have been written on the subjects of philosophy, Man, the mind in various universities;
5. In the past eleven years thousands of men, not connected with universities or groups have originated and forwarded philosophies about Man;

Thus, with all these targets no protest has been made by groups or press against no philosophies.

And now let us look further:

6. Many truly dangerous practices have risen up amongst man such as a new Indian version of whirling dervishism now rampant in England;
7. Brainwashing was introduced in the past eleven years by the Russians;
8. A dozen violent and harmful psychiatric treatments have been developed.

And no sustained protest has continued to be made in the press against these. Indeed the U.S. Government adopted brainwashing early and the British Government and people of the U.S. have accepted new psychiatric treatments, organizations and propaganda without real protest.

Looking at all these things, then it would seem that protests against Dianetics and Scientology do not stem from a knowledge of myself, they do not stem from a knowledge of the substance of the work, they do not stem from conservative or liberal groups, and they are not a protest against philosophy, philosophers, or evil practices, and they are not an effort to protect the public.

If you look this over with cold dispassion, examine it thoroughly from the light of the facts, only one explanation seems to remain.

They are terrified of our postulates!

This analysis places a fantastic discrimination weapon in our hands. In fact the protest is obvious since it is irrational and is not based on common sense.

To any attack by anyone, we can reply, "Why are you terrified of Scientology?" or "Why are you afraid of Hubbard?" or "Why are you frightened of Scientologists?"

For plainly this is the case. People don't even know we reach for withholds - at terror! Protest! Screams!

Now I'll admit to having plied philosophy before within the whole track memory of Earth dwellers. Harm did not result. But evil was destroyed. And I'll admit that evil men sense the germs of their own destruction.

There may be unconscious recognition in this. Maybe its the Fourth Dynamic ank that yells back.

But, of this we are certain. We inspire terror in some men. "Why are you terrified of Scientology?" is the best answer. It as-ises the condition.

I think we ought to use it.

RON'S JOURNAL.

October AD12 has been crisis corner in Scientology.

It seems as if just when we're turning out clears and good auditors a lot of confusion has blown into view. It's not that we won't make it. It's far from that tough. But it just seems unusually emergized lately.

I have been working pretty hard and wanted a rest in the first two weeks in November. I was going to drive down South before the weather got too bad there. But I've had to cancel it out.

Regarding the various situations, it looks awfully stupid outside today.

In England, Town and Country Planning, a device developed to keep land values high for the "right people", came down on Saint Hill for restoring two beautiful small buildings. Three years ago, this Town & Country Planning Authority told us not to bother them. Last autumn before we built, the local authority wouldn't even come down and give us an opinion when we asked them to. Suddenly, with the buildings completed they descended en masse and we've had to have surveyors and architects at work and tons of correspondence and the possibility exists that we will be forced to move the Briefing Course. We are fighting, however.

In the U.S., on the heels of my informing the White House we could help them with their fight against Communism, the Food and Drug Administration came into every large U.S. Org in a space of 48 hours (DC, NY and LA) demanding evidence about the E-meter. Evidently they are trying to confiscate all E-meters in the U.S. This seems most peculiar that they'd want out of existence a machine that detects Communists while they pretend to be mad at them. We'll win out in this, too, if we're careful. Meantime all processing in the U.S. is in peril.

In Johannesburg, South Africa, six people tried to monopolize clearing and destroy the Central Organization there. This is now well under control but has been a strain. Of all these emergencies this has been the most idiotic of the lot. As if anyone could be or go clear with that many overts!

Coupled to all this is the general world situation with very aberrated people playing about with very explosive bombs.

Generally, on organization emergencies I have to carry the ball, and when you add this to everything else I'm doing it seems a bit heavy.

But on the credit side of the ledger we have a lot of recent wins. They took a lot of hard work and they're worth it.

In clearing I've enormously decreased the time taken to find goals in most cases and have the road in on all cases and am working out a very set procedure for all assessments for goals that will remove the question marks and easily find the Rock Slam.

On the Saint Hill Course we're making auditors of such calibre now I was very pleased with the auditing presence and skill of one auditor each from each unit. In training we've made it, even though it remains hard work.

The Mark V E-Meter is in production and will be delivered this week. It's as sensitive as the proverbial princess and her seven mattresses.

The Washington Org has hit new highs under John Fudge and Eleanore Turner and has cleared some people on their own, having to hand now lots of Saint Hill Graduates. The man whose goal was found at the Labor Day Congress has been cleared in the HCC there, I hear by grapevine.

Los Angeles is doing well under Julia Salmen, if terribly short-staffed. Soon, however, she will have many Saint Hill Graduates.

Melbourne is holding up very well under Eliz Williams, although she has no Saint Hill Graduates except in Perth and Sydney which have one each. Relief is, however, in sight.

The worst step is trying to hold the fort technically and economically while key personnel are being trained at Saint Hill. The resurgence of technical in an area after this step is taken is, however, wonderful to behold.

New Zealand has reinforcements en route in David and Merrill Mayo, who just landed at Saint Hill, and held up wonderfully as an org during the waiting time. Zealand is getting back one more Saint Hiller than they sent due to David's marriage.

Durban and Port Elizabeth are now fine. And Capetown, despite the worry and strain of the push on Johannesburg, is swinging up fast after a long period of strain.

The real heroes of these periods are those who hold the fort during this waiting period.

I've been a little worried lately for fear HPAs and HCAs will think I've forgotten them. I haven't. Far from it.

We've managed to formulate "Scientology 1970" which is to say the org shape of 1970 so we could work toward it. And it suddenly appears that it will materialize before 1970. Plans of "Scientology 1970" are being forwarded to all orgs this week, requiring only photostats to be made here first.

The HPA/HCA has a big role in world clearing and in these district and central offices.

The idea of "One Organization and That's Scientology" is receiving much commendation everywhere. The idea of "the private practitioner" has never set well on as it's borrowed from organizations with few answers. You don't have to turn people out to become "private practice" if you've got the answers. There's enough money and money in sight to include everyone in. A united Scientology alone can stand up to the buffets of world clearing.

Another piece of good news is the Washington Tax Status. The organization is undoubtedly going to get its Federal non-profit status after a seven years fight. and NY already have it.

Reviewing Johannesburg, I've learned that it happened because its HCO fell down. Only a temporary secretary was on post and when the org refused to answer up the communications were thus non-existent. Another lesson was not to let people out of Saint Hill while they rock slam on Scientology etc. They accumulate rock slammers.

All in all, it looks like we're winning.

Sometimes it's hard work.

RON'S JOURNAL NO.2.

It seems from here that the world went through a psychotic break in October. Along with Cuba and the near boom of the bomb, with Russia helping India against Red China, things closer to home also went spinny.

There were crises in the world of Scientology in the following places: South Africa, England, Australia and the U.S.

Two of these emergencies were governmental.

One (England) was Town & Country Planning. They have since granted us rights to retain and use our buildings and this flap is over and successfully ended for us, so we don't have to move and the course goes on.

The other governmental emergency (U.S.) was traced to the irate parents of a student who were hammering at FDA (Food, Drug Admin.) to seize all E-meters and close down all Scientology in the U.S. One wonders at their missed withholds! The matter is being fought but 35 Mark IVs are held up in Customs in the U.S. on F.D.A. orders. The F.D.A. has been trying for years to halt our meters. They have authority over all "diagnostic and therapeutic electrical machinery." They pass as wonderful all psychiatric electric shock machines even when they kill patients. One wonders at the political colour that favours machines that murder and outlaws those that disclose truth.

The other two emergencies were caused by Rock Slammers, so upgrade the importance of Rock Slam and ordinary sec checks.

The lesser one was caused by a Rock Slammer, since suspended, auditing the HCO Continental Sec Australia. This situation is in hand now.

The whole disgraceful Johannesburg mess was caused by Rock Slammers. They were two in number - Senogles and van Niekerk. Advertised as clear (by themselves) they both check out on the meter with TA at 1.5 and both RS-ing on LRH and van Niekerk also on "an auditor." Jack Parkhouse returned in time to deliver the new addition to his family and to get things under control from Cape Town. But the tide turned with the arrival of Quintin Schuchage as Assoc. Sec. at Johannesburg, backed up a week later by Joan Oberholtzer as Technical Director.

Aside from the fact that entheta persists, Jack, Quintin and Joan, with good support from Durban and Port Elizabeth, have things well under control. An aside comment on this, the Johannesburg area, with all these "clearing" reports was lousy with wrong goals. Evidently only Vicky du Toit is clear.

It is highly probable that we will shortly convert all SA to Scientology 1970 as private practice was at the root of most of this - next to Rock Slammers.

So the general situation, with a lot of fast coma and hard work has calmed down.

With all this I've been auditing my head off getting data for Routine 3-21, the Twenty-One steps to O.T., and gave up lecturing this week to get it into HCO Bulletin form. About half the pcs were running into goal finding and listing trouble which was solvable only by individual handling or several procedures. I've gotten this all under one run-down with only one of 21 steps varied for the rougher case, so I feel we're way ahead on this now. We made a 1st goal clear this week on course.

Early darkness and autumn chill are upon us. I have my new Pontiac out in the garage (sigh) and no spare instant to drive it. It's my cameras and cars which suffer in the midst of all these flaps.

RON'S JOURNAL NO.3

Well, I just spent one of those weekends where after a full week's work I find myself alone with an avalanche of emergency despatches.

The U.S. Government went more than abnormally insane last week and did the following all off its own little bat:

- (1) Organized a smear campaign in the press to cover up
- (2) An armed raid on a church and
- (3) The seizure of philosophical religious book stocks.

These were Hitler's exact tactics when he got "agin" something. The smear campaign was in Washington D.C. papers, on the streets four hours before the raid occurred. Carefully the papers make no mention of "Church" or seizure of religious texts. The Church was the Founding Church of Scientology. The books were 21 titles of our Scientology texts.

The org today is operating and, though shocked, stood up well to the violence done. Meters were also seized.

Spiritual healing being legal in the District of Columbia gave them no pause.

We are carrying it to Federal Court and to the Supreme Court if necessary. This may be a turning point upwards - for Scientology in the U.S.

The action came soon after I offered Kennedy, a Catholic, help in the space race.

But what is interesting is that no press has mentioned the above (1), (2), (3) facts. Given to the public just as they are, they could ruin the Kennedy regime, if not the U.S. Government over a longer period. They are in the teeth of the Constitution of the United States and abroad would give pause to all this enthusiasm for U.S. domination of world defence. Who wants to be tied up with a country dedicated to religious persecution and Hitler methodology?

So on careful trace I find that over twelve years the U.S. Government, not some special interest, has been sniping at us. Why? If man weren't an animal, how guilty they would be. So the two "great powers" of the world, the U.S. and Russia, both lack integrity, both attempt to smash philosophy and religion, both fail to keep their announced promises. We have a GPM dumb bell pair on this planet, both crazy. And they hold practically all the armed might.

So anyway it was a rough weekend. Just another one in the twelve year long fight to make men free. The DC org was superb! And as a result of our work we'll surely win. You can help too. NOTHING FACTS.

King Features Syndicate of New York very kindly gave us permission recently to reprint the following release of the book Soviet Military Strategy by Ralph de Toledano.

The present lull in the world situation is deceptive in inducing a leisurely sense of time.

Here is the release:

RUSS A-WAR PLAN WOULD CRASH U.S. - SOVIET 'MEIN KAMPF' DETAILS BLUEPRINT FOR HOLOCAUST
by Ralph de Toledano

A 450-page book, smuggled out of the Soviet Union, may jolt the American people out of the horse-and-buggy strategic thinking - that is, if the text is ever made public.

Written by Marshal Vasily D. Sokolovsky and 13 other senior officers of the Red army, it is "Mein Kampf" blueprint for burying the West in a nuclear holocaust.

The book, "Soviet Military Strategy", represents the U.S.S.R.'s official military position. Its major point is, that the Soviet Union must and will launch an all-out nuclear attack on the United States once it has superiority in the new weapon.

While the U.S.S.R. is in the process of seeking this lead, it will continue to operate behind a propaganda smokescreen - calling for "negotiation" with the West, the relaxation of tension, and an end to the cold war.

Whatever concessions the West makes, however, will make no difference. The only deterrent to war, according to the Soviet Union's top strategists, is American superiority in nuclear weapons and the vehicles to deliver them. If "negotiations" serves to lull the West, this is all to the good. But war, as soon as possible, is the fixed policy of the Soviet Union.

This Soviet strategic manual is blunt about Soviet capabilities. Though Comrade Khrushchev has boasted that this country has anti-missile weapons which can "hit a fly in space," the manual frankly admits that this is false. "It is necessary", it states, "to create effective means" to destroy missiles and bombers in the air. When the Communists have created these "effective means", they will be that much readier to put their plans into operation.

Here are some of the key points in the Soviet nuclear war plan - now being secretly studied by the Central Intelligence Agency and the Pentagon's highest echelons:

1. A surprise attack by the West on the Soviet Union is still possible. Therefore "political" means must be used to prevent it.
2. The American concept of "strategic defense" - the "second Strike" thesis - is thoroughly repudiated as impossible against an enemy with a lead in nuclear armaments. Soviet strategists believe that victory can come only to the nation taking the offensive.
3. War can be won only by a "first strike" and through the "total destruction" of the enemy. "Wars of liberation" merely serve political ends.
4. In taking the "decisive step" of starting a war, the Soviet Union will throw most of its strength into the first blow.
5. The former Soviet doctrine which placed large land armies at the head of the list as most important has been cast aside. Major priority is now given to "strategic rocket troops."
6. All troops must be developed long before the attack signal is given. These forces must be dug in as close to the American heartland as possible so that they can be moved readily after the knockout blow.
7. Radioactivity is not considered a military factor. Field commanders will be under instructions to move into contaminated areas immediately, regardless of the effect on Soviet troops exposed to radioactivity. This will allow the Red army to

occupy strategic points before the United States has had a chance to recover from the shock or to deploy defending troops. Seizure by the Red army of vital areas will make a "second strike" by U.S. Polaris submarines ineffective in restraining the Soviet assault. U.S. retaliation will cause great loss of life in the Soviet Union but will be of no military consequence.

ESSENTIAL INFORMATION EVERY SCIENTOLOGIST SHOULD KNOW

To correct certain misconceptions held by newspapers and areas of the public, the following information is released to assist Scientologists in correcting such ideas:

INCOME

10% Every Scientology Organization and formal activity pays to HASI in England 10% of its gross income. This is used for administration and research, and is supposed to but does not cover the cost of bulletins, cables, staff salaries, and the expenses of Scientology headquarters. LRM does not receive this 10%. Reference Palmer & Co., 205, Chingford Mount Road, Chingford, London E.4., Chartered Accountants, and the books of HASI and its HCO Divi worldwide. All student fees of the Saint Hill Course and contributions are likewise deposited to HASI Accounts as above and are used in operating expenses and are not received by LRM.

LRM has his own personal income. Organizations pay his expenses when travelling and some research expenses. Organizations currently owe LRM considerable sums of moneys loaned to them by LRM - Johannesburg over £3,000, London £7,000, etc.

LRM paid all the original costs of research out of his own pocket. The royalties of his first book, DIETHE, were all given to the first foundations. LRM owns Saint Hill as his own home, paying for it with his own monies received from the sales of a Virginia property and a yacht he owned. He receives no rent for Saint Hill partial use by HCO Division of HASI or the Saint Hill Course.

There would be nothing wrong if LRM did make money from Scientology as Scientologists are perfectly willing to pay him for his services in administration and research. Boards and officers often express the hope of paying Ron book royalties and sums for good will and are loaned and LRM would be perfectly willing to accept them. LRM in some Orgs has drawn a nominal salary in the past as Co-ordinator of Research and it has been well earned but he has drawn no pay for the past several years until lately when £25 a week was given him for his out of pocket expenses.

ORGANIZATIONS

The early Dianetic Organizations were formed and controlled by boards of directors and in early 1952 failed. They were not under LRM control and direction, their press and public relations were mishandled by these boards. To the late Joe Winter M.D., an original board member, we owe the stress on psychosomatic medicine. "70% of all ills are psycho-somatic, Dianetics can cure them" was Winter's and these handouts were written by Winter. To the first publisher we owe "any two can do it by one reading of this book."

In 1952 in Arizona, LRM started the first Scientology Organizations and these, under his continued direction, have had a consistent and enviable record of forward advance until they now cover the major areas of the world except Communist areas, and bids are now being made by these for our help.

The record of advance and growth under LRM direction and the able service of those he has appointed mark something like a record. Any International firm would have paid \$125,000 a year to a general-manager who could have duplicated this feat.

Organizations are being made separate and autonomous as rapidly as possible with LRM serving on each board.

LRM does not own Scientology Organizations. He does however retain ownership of all copyrights and trade marks and registered marks so as to ensure their proper and ethical use

PRESS

The bad handling of early Dianetic press has caused an inheritance of bad press. This tide is however gradually shifting.

It is notable that all press is based on American Communist and AMA inspired attacks and not once in 13 years had any member of the American press ever personally interviewed LRM. These stories, then, were all written without interviewing Ron, an important point. This record was recently broken by a large U.S. magazine (The Saturday Evening Post) sending its star writer to interview LRM at Saint Hill.

DEGREES

You often hear slurs on LRM "lack of degrees". LRM was trained in mathematics and science at George Washington University, in government at Princeton and was given his doctor of philosophy degree by Sequoia University in California. But there are no degrees or courses given in Universities for the subjects he researches. He does not practice in any field requiring a degree. He does not need or want degrees, but even so he has them.

THE E-METER

The E-Meter is actually a psycho-galvanometer invented about 60 years ago. It is capitalised as a lie detector. One E-Meter is a transmitter version which is tuned to a certain mental area. It is used during sessions to find areas of focus in the auditor's mind and to draw conclusions. It does not draw conclusions and will not lie. It has never been used as a lie detector.

The Meter is feared by subversives. Only Scientologists with meters could detect subversion. Trained Scientologists are also the world's foremost meter or lie detector meters. Therefore subversive and criminal elements are terrified of and fight the meter.

That Scientologists seldom use the meter to detect subversion and only use it to assist people to know the truth about themselves, does not deter this attack. Cruder E-Meters are generally available in the world and one version can be bought in toy stores in the U.S.

THE POLITICS OF SCIENTOLOGY

Since Scientology can free the individual, its politics easily become those of freedom. These days of huge bureaucracies a line of thought designated "Rightist" is growing up. Rightist is defined "as one who believes in limiting bureaucracies and in the rights of individual."

Therefore Scientology whether it will or no gets classed as a "Rightist movement". It is listed in directories in the U.S. as one of the first 17 Rightist Movements of the U.S.

The Communist is opposed to limiting the power of the state. He wants a total state and actually Totalitarian. He does not believe in individual rights but only in group rights. He carries this into economics and even denies one's right to be paid for his work. This is very in modern garb.

Therefore Scientology collides with Communism. The Communist uses all manner of fellow travelers to spread his ideas and this helps to give us bad press.

The Medical Associations and drug manufacturers fear the appearance of easy drugless living and so campaign against any economic threat to their multi-billion dollar income. This also gives us bad press even though we have small interest in healing.

But press has no real bearing on Scientology growth. Good news stories and bad news stories alike do not really increase or decrease Central Organization traffic. Scientology is by word of mouth, not by press.

SCIENTOLOGY MEMBERSHIP

There are several million Scientologists in the world today. Closer estimate is impossible due to its constant growth and loose structure.

SCIENTOLOGY AS A RELIGION

EASI was incorporated as a Religious Fellowship in 1952, two years before there were any discussions about churches or ministers.

Philosophy dealing with the individual as a spirit is normally classed as a religion. The same type of material as Scientology was attempted about 2,500 years ago by one Gautama Siddhartha and became the world's oldest civilized religion, known as Buddhism. Laws of life, exteriorization and other materials of Buddhism are similar to Scientology. Scientology, however, is able to achieve results even in early stages that Buddhism could not. This does not make Scientology Buddhism but it does place it firmly in the area of religion.

Theosophy, organized as a body of knowledge similar in text to Scientology has been declared a religion by U.S. Federal Courts.

Scientology is therefore a religion. The only question was whether or not its organizations should be formal churches and auditors ministers. Some Scientology Organizations have become Churches, some as in Australia have remained simply religious fellowships. There has never been any serious question of Scientology being a religion since by definition knowledge and study of man as a spiritual, rather than an animal, being is of course religious.

That Scientology organizations "use religion for tax purposes" is quite false as the majority of the organizations, while religious, do not enjoy tax exemption and pay their taxes. So the argument has no point.

WORKABILITY AND ETHICS

Scientology is the only activity on Earth that dares practice the following ethical code:

If a person believes he has not been helped his money should be refunded to him promptly and in full.

This now applies to training as well as processing. All auditors and organizations are bound by it.

Instead of letting somebody worry you about whether or not Scientology works, you would better to point out this clause of our operational code. Nothing that didn't work would be offered that. Not comparing Scientology to healing, but if medicine or psychiatry were bound themselves with that clause they would go broke within a year.

Scientology works. It works, however, only as well as the auditor is trained and the participants. These, not the technology, are the only limiting factors in Scientology results.

This letter so far, has been mainly devoted to what Scientology is. It only touches what various hostile elements are doing to it.

well as to us choose to accuse Scientology of - a money making fraud that means to overtake all the poor Communists and take food from the overfilled stomachs of the Medical Doctors, drug manufacturers.

But Scientology survives all that very well because of the following reasons:

LRR

If anything were really wrong with LRR, his past, his income, his mind or his work, hostile elements would long since have swept him away. But he has survived 13 years of constant hammering. During that time he has carried his jobs of research, administration and dissemination to success in all three fields. The task and scope of administration alone would have been full time for any executive director of any large organization and so still is this record that probably many international corporations would hire him on the spot for \$125,000 a year. In dissemination since 1950 he has given close to 30 million words of lectures on Scientology and has written tens of thousands of pages of bulletins and books. In research, he has investigated areas never before approached by Man and has spread out a whole frontier of new knowledge and achieved conditions and states of existence not approached by any other researcher or philosopher in Earth's history.

... It takes more than a few ill-natured cracks about income or degrees to knock away any portion of these actual achievements. They have never been topped and now in the field of research they can't be.

He was clear before 1962 and is now, at this writing, four goals down from present time toward O.T., Scientology's highest state.

He badly wants a vacation and some time to do the final recording of Scientology data for its upper levels.

His last vacation was a boat trip to a U.S. Congress in 1962. Since January he has crowded the next ten years of scheduled research in Scientology into 8 months and completed it. Therefore he feels Scientology owes him a few months to catch his breath.

He considers the research part of his task concluded in August of 1963 since all targets ever envisioned were realized as of that date and only codification and recording remained. In short, he was not stopped in his principal endeavour - research - by any hostile attempt or distraction in the past 33 years, with their wars, upsets and confusions.

SCIENTOLOGY STAFFS

Headquarters, Central Organization, City Office and field staffs and auditors have contributed more than their share of loyal and devoted service to LRR and Scientology in the past 13 years and the story of almost any one of these people is itself a matter for legend. What they have gone through, and what they have done and sacrificed to make Scientology come fruition as a subject and a world wide organization ranks amongst the great stories of history.

It is they who carried the guidon, took the personal shocks of hostile reception, achieved the results, planted the standard all over the world and kept things going onward and upward. Few fell, few strayed but even these had contributed their best.

It was through their efforts that the public stayed interested, that the technology remained pure, and that funds came in to handle research and administration. To them belongs the glory of ultimate success for they carry on. Humanity and future Scientology owes them a debt that can never be repaid. These were and are good people, the best that Earth ever had.

They work for little, they work hard. They do their jobs and not even their name in lights is there to help. Across the world they generate the high headed, confident plan that has made Scientology win through.

A suitable designation and award is now being worked out for all these people.

SCIENTOLOGY'S MISSION

The basic mission of Scientology is to give Man wisdom and freedom.

This is a civilizing mission, but it is also one of individual freedom.

Men are prisoners of themselves and only truth can set them free.

If all men were sane then Society would be sane.

If you, the individual, know the truth and were processed toward the truth, you would be free. Only lies degrade you. This is the lesson of Scientology.

It is impossible to combat this mission and so we seldom confront the opposition or take it seriously. The opposition deals with days where we deal with eternity. A thousand years from now Scientology will be a bright name when anything now governed will have vanished from the role of nations.

No organization which can achieve individual immortality ever worries much about temporary hostility. And individual immortality is not only in our grasp but is now being achieved.

Our mission therefore finds itself in a barbarism and like barbarism it will be brought back. You can't civilize man out without getting barbarism.

Scientology will someday be acknowledged as one of the great efforts to civilize Earth, with Buddhism and other such movements. Indeed it will have a higher reputation than that. But in its beginnings - now - it knows hostility and baffles the clergymen.

FUTURE PLANNING

It is the full intention of Scientology to shift emphasis from the taking of fees for auditing to teaching and letting individuals process amongst themselves with our help to the levels to which they are trained. All qualified auditors will be granted training rights at the level of Hubbard Apprentice Scientologist and Classes Zero and One. It will be found that cases respond best to the levels to which they have been trained. It is certainly more ideal to be trained and to co-audit with auditors of the same class. And technically it is found generally true that cases require a level of understanding comparable to the level on which they are being processed. The highest levels of today's processes require full training at those levels before the person as a preclear can hope to achieve them. This is a technical fact and it holds for all classes, if to a lesser degree. Considerable research has revealed that nobody not trained to O.T. process levels will be able to cope with the training, if only because no high level case analysis can be done.

Therefore we are looking at a new era, an era of training and co-auditing where the rule will be "No Auditor may be audited outside his class or on processes above his Class." "All Trained Auditors may train to Levels Zero and One and certify and class at those levels." All materials of the past years are being charted by class for immediate release, all are to follow this plan.

Income for auditors and organizations will be shifted gradually away from processing fees over to training income. All auditors should consider themselves auditors and instructors. While none will frown at a private auditor processing for a fee, it will be expected that he or she more and more devote time to training.

This charts the new person through all the way, step by step to O.T. and, frankly, the only way anyone can make it with security and minimal upset and the best way to keep the bridge open. While it may take some years for them to achieve O.T., they still have the bridge open all the way and their cost will be only a fraction of what it might be.

Now that the skills for O.T. are achieved they are found to be very precise. The untrained will fall by the wayside. They just can't do the highest level processes without case preparation, and full training. But despite this, the way is still open and can be followed.

Stability is such that no significant process development has now occurred for almost months. And skills for each level now exist in a final form. In short the whole has been opened and how it can be travelled best can be planned with complete security. Scientology finds itself at that happy state of having achieved the technical completion results always hoped for, and a reality level of processes that can be applied to every

Thus we are indeed planning our future, solidly and with confidence, having emerged from ten years of trying and hard trials. Ours is the bid for eternity that succeeded.

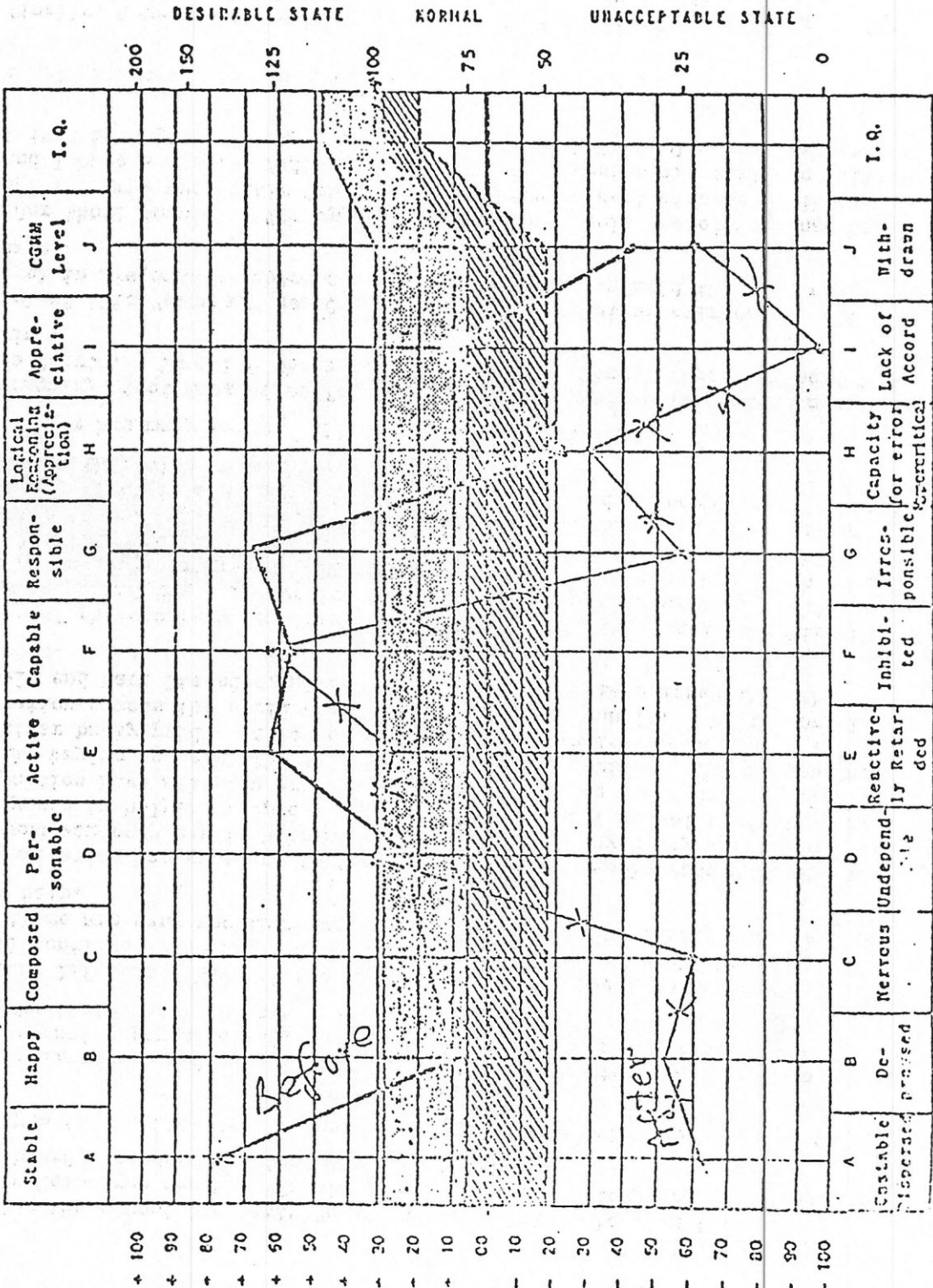

THE MELBOURNE ENQUIRY INTO SCIENTOLOGY

Regarding the opposition party "enquiry" into Scientology in the State Parliament in Melbourne and its "findings" the following story was written in reply by L. Ron Hubbard, Founder of Scientology.

Does a Man in the 20th Century have a right to write what he believes to be the truth?

I am a philosopher and a writer. I am not a psychiatrist and have no degrees for it. I am not a psychologist, and there are no degrees for that. I am a philosopher by trade and I do have a degree for that.

In a long lifetime I have always written what I believed to be true and I am afraid, will continue to do so. Some millions of copies of my books have been bought, so there are many who think as I do - that Man is basically good, and that he deserves help.

An organization has grown up to forward my work. People read my books and come to me and somebody has to help me care for them. Any money they receive from people, they use in helping people. I do not get it as I do not need it. Even my book royalties have all been used in this work. These are decent people. They are only trying to help others. Nobody is getting rich. On the contrary, they are rather badly paid. A lot of money can be tallied up but then, it's a big organization across the world and it costs money to run it. What I own I bought myself and have loaned or given the organizations more money than they have ever paid back.

The lot of philosophers is often a hard one. They think new thoughts and advance new ideas and these are resisted by the old, quite naturally. But the world must go on, must progress. The normal lot of any philosopher is to be tried during his lifetime and either exalted or forgotten after he is dead. This matters little to me. My trade is that of a writer of philosophy and the issue is, do I have a right to say what I believe is true? And do people have a right to believe what they wish to believe?

McCarthyism has many faces. It is still abroad today.

The "enquiry" that dragged on for years in Melbourne was in fact no more than a "Kangaroo Court". They had their conclusions drawn long before they held the first hearing.

In England this "enquiry" would have been laughed out of existence. It was quite illegal in its conduct under common law. And I'm afraid the Q.C. would have been disbarred.

Consider these points. The opposition witnesses held secret meetings before the hearings to agree upon their testimony. They even kept minutes of those meetings and I have a copy. Although the Profumo witnesses are still in jail for doing just that in England the Q.C. in Australia and their parliament shrugged it off.

The court transcript is illegible and contains enough errors to make it senseless.

And finally, I was not permitted to appear in defense of my writings. Our solicitors Nossie and Morris of Melbourne petitioned their justice department and were refused. They petitioned the enquiry and were refused. They urged the hearing be held in England since I was not permitted to go to Australia. And this was refused.

These and many other errors give one a picture of a confused scene. And the findings, based on no facts, are at best an hysterical outburst.

Well, Australia is young. In 1942 as the senior US naval officer in Northern Australia by a fluke of fate I helped save them from the Japanese. For the sake of Scientologists there, I will go on helping them. They have a lot to learn.

I feel sorry for them. They are afraid.

Fifteen years ago my writings were ridiculed by the various vested interests. But as time has gone on these interests have felt more challenged and have now issued what amounts to a self condemnation.

Socrates said, "Philosophy is the greatest of the Arts and it ought to be practiced".

I intend to keep on writing it and practicing it and helping others as I can.

The dark ages have not yet returned.. The three witches burned at the stake for "heresy" who lie buried in our East Grinstead Church cemetery are not forgotten. That example of barbarism helped push from the shores of England tyranny over men's minds. The members of the enquiry in Australia are members of the same Church that burned the witches in our High Street.

Let us be thankful that this desire to persecute is now 12,500 miles away from us.

I will continue to write what I think and believe. And will go on until lightning strikes or the atom bomb comes. And I hope a Man's right to do that is still his right in this our times.

SUBJECT: OUR U.S. SUITS AGAINST NEWSPAPERS ON FDA RAID STORIES ETC.

The suit which may be easiest to bring is against the newspaper publishing the FDA and other libel and slander naming in it also the American Medical Association, the American Psychiatric Association, the Better Business Bureau and the clipping or press bureau that forwarded it and the charge probably best consists of "Libel and slander to forward a Conspiracy to monopolize healing in contravention of the Sherman Anti-Trust Laws" or a similar anti-monopoly act.

Scientology should not be put on trial or defended as such and this should be avoided, as evidence for such charges are inconclusive.

However the treatment of the AMA, APA, BBB (and its collusion with the U.S. government on the same subject) of the chiropractors, AMA lobbying against other healing group for pro MD legislation all add up to conspiracy easily proven.

Lots of evidence is available from the National Health Foundation and other healing groups opposed to this clique.

The BBB issues pamphlets about "Cures" and "Quacks" written by the AMA.

The fact that the AMA has worked to make people think it is a government group while it is only a private company like ours can be made to tell heavily.

The Australian mess was sparked off by the continual collusion of the AMA, APA, BBB and the U.S. Consul in Melbourne to whom libel was traced some years ago.

The AMA held a huge Congress in Washington D.C., got it addressed by government leaders, and branded anyone else engaged in healing a "Quack" and has since kept this exhibit alive in Washington.

Any libel and slander around about myself or Scientology is based on a 15 year endless campaign by this group. The AMA issues "news releases" to magazines and papers villifying us. One such went to the Diner's Club Magazine in the U.S. It is a standard "news release" as issued by the AMA.

Out of this vast fund of clippings and propaganda, "new" stories are made up from old clippings. No. U.S. newspaper reported has ever interviewed me. Only Phelan of the Saturday Evening Post Magazine did and he consulted before me hundreds of clippings he had been furnished with, not us. He did nothing but read these old clippings to me challengingly. He never asked anything about us.

The American Psychiatric Association psychiatrists have no standing under law of any kind but depend on being Medical Doctors to practice. Psychiatry has no legality whatever anywhere except a created illusion in the public mind done by advertising in covert ways and libel and slander of all mental healing groups other than those of medical doctors of the AMA.

A direct tracing of the FDA attack goes back to the AMA Congress in 1962 (Sheraton-Park Hotel 1962?).

...to establish a healing monopoly by libel and slander

and undue influence of governing persons and agencies by libel and slander can be proven rather easily. Full minutes are available from the National Health Foundation in Washington D.C.

It has been going on about myself and Scientology for 15 years despite all evidence to the contrary. It is probably necessary to tie all this up in one suit, to include a continuing bad press and thus choke off a defense against our suit by their reading press clippings to the court.

As a side comment, before I seemed to threaten the multi-billion dollar healing empire of the AMA and APA, all my personal press was bountiful and good. It included stories of my expeditions, Hollywood successes, war successes, etc. Suddenly, after 20 years of fine personal press in U.S. papers, (1930-1950) the moment my first book on healing was published, good press became violently bad press so that in 1950 "Time Magazine devoted more space to my doings than the President" as one of my press agents once said. And it was all bad press. My book said "any two people by reading this book could help each other" and the book invaded psychosomatic medicine, which accounts for 70% of Man's ills. The change from hero to devil occurred in one day - May 9, 1950, the publication date of Dianetics The Modern Science of Mental Health - the runaway health best seller of all time.

But the Doctor's Shutes in Canada developing Vitamin E Therapy (curing 50% of the average doctor's income cases - heart disease) and hundreds of others have also felt the libel and slander tactics of the AMA et al.

This therefore is a field of attack crammed with evidence pointing to conspiracy to monopolize healing by one group, the AMA, extended into the APA's mental healing by reason of requiring a medical doctor's license to practice on the mind. Thus the medical doctor has it sewn up and by discreditable means seeks to extend his monopoly. Medical doctors aren't even trained in the field of the mind.

There is no evidence that qualification as a medical doctor cures anything or that modern medicine is necessary for cures. The Better Business Bureau pamphlet says nobody can cure anything including the MDs. Almost no discoverer of cures was ever a medical doctor, no matter what line of illness one looks into. They have planted the idea in the public mind that healing of anything by anyone but a medical doctor is dangerous. But they also hold that treatment by a non-member of the AMA is also illegal even when a medical doctor (Army and Navy trained doctors are refused the right of private practice by the AMA).

Yet, as psychiatrists they kill their patients. And adequate proof exists that medical practice is dangerous.

They excuse the monopoly by saying it is unsafe not to have one. None has ever also said it is unsafe to have one. There are many therapies besides pills and the knife. The AMA debars them all by libel and slander to maintain the monopoly of a private organization of practitioners in a multi-billion dollar healing business kept to themselves alone.

POINTS TO KEEP IN MIND

The points to keep in mind in the U.S. suits are:

(1) That defending attorneys will quote old clippings as facts unless these are included and answered in our own charges.

(2) That the medical doctor in issuing pamphlets through the Better Business Bureau states that "anyone who says he can cure anything is a quack" and that the medical doctor states he can't cure anything - so why should he have a healing monopoly?

(3) That influence on the government and public over many years by the actual identity of the AMA - a private group.

They defend their monopoly only by creating fear and confusion.

(5) That issues to press by the AMA and their companion medical doctor group, the AMA, consisting of libel and slanderous attacks and are their means of maintaining a monopoly.

(6) That the AMA does this to all other healing groups.

(7) That neither myself or Scientology need be tried as evidence of defamation issued by the AMA exists concerning many healing groups.

(8) That the present position of monopoly of the AMA was won by such tactics.

(9) That I was never given any bad character anywhere until 1950 when I published a book threatening the profitability of healing and threatening to break their monopoly. It is easy to prove any charge made in the press by the AMA false. Otherwise I long since would have been put out of action.

(10) That the newspapers and clipping bureaus have uniformly forwarded AMA slander and have not ever sought or published actual interviews of myself. That all actual evidence has been carefully avoided for 15 years.

(11) That it is not necessary to refute press charges over the past 15 years but to use them to show (when attempts are made by the defense to use them) that the campaign is of long duration and is an attempt at monopoly through libel and slander.

(12) That defending against this continual attack has cost us millions and brought us near ruin in some areas and that damages should be historic.

The following news story appeared in the New York Herald Tribune, shows the latest tactics in "treatment". Caning and other types of mayhem have long since been outlawed.

This "treatment" would make it impossible to properly treat the patient afterwards and would lower general ability. Such matters can be handled by Scientology without brutality.

Psychiatry has no basis in law. Most of its technology comes from Russia.

Punishment-Reward Therapy Gives Pervert His Freedom

WASHINGTON, Nov. 23 — A Silver Spring, Md., father who admitted molesting children is on probation today after a psychiatrist testified that the man had responded favorably to painful electric shock treatment.

The psychiatrist, who treated the man privately, told Prince George's county circuit judge Robert B. Mathias that he successfully applied "learning therapy" to the man.

The man, 35, had pleaded guilty to committing an indecent sex act. Judge Mathias, noting that "this court does not believe that deterrence always means imprisonment," ordered ten years of probation and continued therapy.

The psychiatrist, Dr. William H. Philpott, told the judge that the man engaged in "sexual play" with his own and two neighbors' children, all between six and eight years of age.

Dr. Philpott said the man had received "insight therapy" from another psychiatrist some years ago. This helped him understand his ailment but did not cure him.

Dr. Philpott said he "educated" the man to shrink from certain activities by the same manner in which a child, by being spanked, learns right from wrong.

15-Volt Shock

Electrodes of a dry cell battery were attached to the man's fingers. He was asked to dwell mentally on his sex play and then was given a shock of 15 volts.

"This just shatters it," the psychiatrist said. "It vibrates his entire body. It brings a tremendously high level of pain."

Another part of the treatment,

he said, consisted of instructing the man to imagine pleasant scenes of playing children with no sexual overtones, while breathing a mixture of 70 percent carbon dioxide and 30 percent oxygen to promote exhalation.

The shock taught him to say no, Dr. Philpott said, and the following pleasant thoughts eliminated depression.

The process was repeated for 21 hourly sessions. After 15, the doctor said, abnormal desires disappeared.

Dr. Philpott said he had "no expectation the problem will return at all." He said he wanted to give ten more treatments to insure stability.

"Educated Out"

Once such desires have been "educated out," he said, it would be unlikely for them to return. He said, however, that "this man has certainly been in trouble and ought to be checked" regularly.

The "learning therapy" treatment is commonly used in Europe and Russia and has been used in this country for about five years on neurosis in general, using relaxation and pain responses for training out symptoms, Dr. Philpott said.

Questioned later, he said that the method is successful in about 50 percent of neurosis cases. He said that alcoholics, drug addicts, and psychotics are being successfully treated, although valid statistics on percentages of cures are still unavailable.

He said the treatment should not be confused with shock treatment used by psychotherapists to jolt patients out of a traumatic state, but rather is a variation on Pavlovian thinking, by which a subject is rewarded for good thoughts, and given pain for evil ones.

ENQUIRY RUMOUR UK

1. The "news" that some Lord is "going to ask a question in the House as to why the Health Minister here does not conduct an Enquiry into Scientology like in Melbourne" as published in the "News of the World" which we are suing gives us this planning.

2. First, it isn't anything to worry about.

3. Melbourne went awry because it was a non-compliance. Hemery gave the Melbourne Office permission to agree to an Enquiry. I okayed this: That we agree into an Enquiry into all mental health services and activities. This was the order. Hemery or Williams narrowed it to Scientology only.

4. Obviously we could have had a ball and put psychiatry on trial for murder; mercy killing, sterilization, torture, and sex practices and could have wiped out psychiatry's good name.

5. That went wrong and Melbourne wouldn't follow any other order either. So it was a mess.

6. If we are ever so involved again we demand one on all mental healing activities including psychiatry and demand it loudly. And lead them up the path to slaughter.

7. Planning would be if any more is heard of this:

(1) MarySue will write a letter for the Chaplain to all members of Parliament and have it photolithoed and if it hots up mail it to all members of Parliament.

(2) Get a detective on that lord's past to unearth the tid-bits. They're there.

(3) Stress sex and blood in psychiatry and collect data and mount an all out attack in the press on psychiatry, so that "Mental Health" sees that they are going to get hurt and will cool off.

(4) If an Enquiry after all occurs and we are pulled in, we try only Melbourne's illegalities all over again (not their transcript) and try psychiatry only. We refuse to discuss or describe Scientology. As near as we come is "Well Scientology isn't like psychiatry. In psychiatry they think adultery is a cure for.....". You get it. Curve every answer with answers that M A K E L U R I D P R E S S T O P S Y - C H I A T R Y ' S C O S T . Papers by policy only want blood and sex - so give them Psychiatry's and they'll print it. Further couple the words Psychiatry and Capitalism - allege that Psychiatry is the Capitalist tool (a Conservative opened the attack in the UK) and round the press beating the drums for us.

(5) Refuse to let the enemy introduce Melbourne transcripts as suits are in progress - "sub-judice". Use only Melbourne illegalities.

8. Remember these things - we won against the FDA. We are winning on US tax. We have caught the ball on UK tax. Part of our trouble is that we're an up statistic and governments are SP and strike at all rising statistics. (See Income Tax scales of tax; as your wage rises the penalty percentage rises).

9. The Melbourne staff set up a nice new org in Adelaide and other states in Australia are revolted at Victoria.

10. The US is clean operating ground.

11. And England's Parliament is not about to pass or even introduce a law barring religion or philosophy. After all these aren't ex-convicts.

12. These flurries can be expected. Plan for them and handle.

13. This is nothing compared to what will happen when we start taking SPs out of the government! They are rightly afraid.

14. So don't you be. Tomorrow belongs to us. Inevitably there are bumps in the road.

COMMITTEE FOR SANE PSYCHIATRY

1. If any staff member has a knowledge of press and an acquaintance with the conditions of the insane in institutions he or she should contact the HCO Exec Sec Communicator WW, Fred Hare.
2. We are forming a "Committee for Sane Psychiatry" that will be charged with the responsibility of bringing to the attention of the world the brutal treatment and sex orgies in institutions and drive psychiatry into accepting lawful regulation by Parliament and Congress. At this time psychiatry has no legal standing and conducts itself in a totally outlaw fashion.
3. The campaign is to be hot and heavy and well financed by us.
4. Case histories of brutal savage treatment are to be collected and the lurid nature of "treatment" is to be fully documented and exposed by the Committee.
5. The Committee is to take full responsibility for the campaign and has instructions to make it loud, lurid and effective.
6. The object is to obtain legislation by press campaigns and public support to make murder, mayhem and sex violation illegal in institutions for the insane.
7. The organization of the Committee is the responsibility of the ES Communicator for Dissemination WW.

SUBJECT: THE CALCULATED RISK

The calculated risk taken on 23 January, 1963, has paid off. And nothing can stop us.

On that date I saw that when the gun-waving Federal Marshals stormed the Church in Washington, we were in for a series of raids and enturbulent actions by governments.

Therefore, as the officers of the various areas can tell you, I ordered them to fight a delaying action while I completed the research.

The strategy was this - the only thing which would ultimately win for us was total technology. If I interrupted research to swat flies, we might lose. Therefore I handed over most of the defense to others and speeded up research.

This was somewhat like seeing the Indians in the distance and instead of readying a barricade, going on inventing a new weapon on the gamble that you would have completed the job before the first brave got to you.

Well, "we done it". Melbourne fell. DC barely held on. Even Saint Hill got its whiff of grape. All orgs were hammered. But staffs stood up splendidly. And the research was completed.

By working 18 hours a day on research and the rest on administrative matters, by August of 1965 I had the full answers to total freedom.

Over a hundred Scientologists were enrolled on the Clearing Course and started toward Clear and Operating Thetan.

In the spring of 1966 the first Clear graduated from that course with many close behind.

And in the nick of time.

This material and these people are scattered all over the planet. Scientology data now couldn't be isolated and burned by an army of agents.

No matter what happens, Scientology today will keep right on going.

History is about to be written out loud.

The only thing you could do to a Clear or an OT would be to make him laugh. But that isn't all a Clear could do. I trust you get it.

Well, the calculated risk paid off. The ultimate "weapon" was attained before the shades of night hit the planet, before the Big Bomb went and before suppressive groups totally shackled Mankind.

The ultimate weapon is total freedom. A freedom no benighted beast can send to Auschwitz. A freedom no gestapo can curtail. A freedom that is completely unqualified.

It is a good thing beings are basically good..

Freedom to be free or to strike at will without any fear of retribution could otherwise be rather grim.

The higher the release or clear, the more decent a being gets.

So we made it. In all the cons, apparently only we made it. And whew it was a near thing.

But in the immortal words of Tom Esterbrook, "there goes the old ball game". The job is done.

If you're not enroute, by the way, you better hurry up and join the crowd. We'd miss you.

PROJECT PSYCHIATRY

In accordance with HCO pol ltr 17 Feb 1966, the HCO Area Sec SM will organize it with great care in the selection of personnel whose bona fides must also be passed on by the Ad Council SM and Ad Council NW. The Section personnel must be procured quickly by ads in London papers giving our London phone number in the ad for relay to Saint Hill.

The ad should read "Investigator: services of trained personnel required for interesting work. Phone Langanham 3601". Repeat the title ad with "Inquiry Agents" as its lead; Advertise often.

Five in all are authorized with the Section Officer chosen by statistics after work is begun.

Stenographic and file personnel must be given this section.

The top budget per week including salaries and expenses of all investigators and clerks is £300 and it must be kept below that until raised by my SECSD and based on results.

No agency may be hired. Our upsets in legal, accounting and investigation stem from hiring outside agencies instead of individual professionals as staff or hiring persons who like the recent accountants "weren't really part of staff". Our investigators must be our own staff and reliable.

THE PROJECT

Project Psychiatry arises by the psychiatric attack on us in the US, in Australia and now England.

These attacks since 23 Jan 1963 follow my withdrawal from heading up our investigatory actions of attackers. So long as we investigated attackers, the attacks folded up. When we ceased, the attacks took a new violence. This is what changed that gave us a down statistic in this matter of attacks. It is repaired by the organization of Div 1 Section 5.

The attacking group as may be expected has a bad background. It is nowhere legalised by name under law. It derives any "authority" by medical degrees but psychiatrists are not qualified medical doctors in actual training and practice. Insanity has no precise definition, but is whatever they say it is. And whoever they say is insane is usually somebody who is in a temporary exhaustion or who doesn't agree with them.

There is a conspiracy here we have gotten across the path of. Any person in the world can be pronounced "insane", killed or assaulted and made incompetent at the whim of any psychiatrist. Further they pretend they can suspend civil rights! This is a violation of human rights. And far too much power for one group composed of men who at best act insanely when faced with any challenge.

We do not know if there would be any "hopelessly insane" people if there were no psychiatrists: For insanity is anything anybody says it is.

Hilter invented the pre-frontal lobotomy to make farm zombies. LSD25 as a drug administered to a person makes him temporarily insane. The Russians abandoned all this realising these "treatments" were Fascist, were begun by the Czar's secret police and have yet to cure anyone of anything except life. "The World Book" states they do no good.

Anyone dying as a result of an operation on the brain (and they generally do, at once or in a few years) has been from our standpoint, and in view of the fact that it helps no one, murdered. Anyone given electric shock has been assaulted, as shock hasn't ever cured any "insanity".

A psychiatrist today has the power to (1) take a fancy to a woman (2) lead her to take wild treatment as a joke (3) drug or shock her to temporary insanity (4) incarcerate her (5) use her sexually (6) sterilise her to prevent conception (7) kill her by a brain operation to prevent disclosure. And all with no fear of reprisal. Yet it is rape and murder.

There are fantastic statistics on this already. Thousands killed yearly by shock and operations, a rising rate of insanity, rising costs for insane appropriations, and all with violence.

Psychiatrists violently attack not only persons but groups such as curs. And they have very dirty hands. And the public hates them, they have no large membership and buy no advertising.

They pretend some sort of government position. They are a private group; in the US they are a stock company. They have no more official position than bookies. Yet their own megalomania (delusions of grandeur) lead them to pretend a mighty status.

Lord Balmiel's Mental Health Association has no more official status than the Plumbers Association! Yet he can, as an MP, pretend for his group official public status and does.

If these violations of human liberty aren't checked we will soon see "thought police" and an end of individual rights.

I have done a preliminary investigation. I find the material available in individual psychiatrists enormous. We do not care about their conspiracy to rule the world even if it exists. They are no stronger than their individual practitioners and they are weak.

All we want are case histories from complaints by relatives or friends that fill our files with evidence of murder, assault and rape under the guise of "treatment". We only want actionable evidence. Testimony that "Johnny wasn't so bad until he saw Dr. Kut. Then he got shocked and got worse". That's assault. "Bob was all right but after he saw Dr. Mutt he was worse and then Mutt operated and Bob died". Murder at least in the second and we hope with enough evidence to be first degree murder. "Lvelyn became sexually promiscuous after she was treated by Dr. Gutt and told me he raped her". Rape. By getting testimony and evidence we can amass a collection of cases that by their volume will demand arrests and trials and an exposure of psychiatry for what it is. If we are further troubled we will start feeding the data in any enquiry demanding arrests.

If we are challenged with incitement to riot we claim we didn't but they did by their actions.

We also will form committees to use this data, collecting together a lot of protest committees that already exist.

Psychiatric blockades, Psychiatric Auschwitz all proven by individual cases.

Carefully do not attack medical doctors as such. You will find they will disown psychiatry at the first breath in fear which will help us.

We want at least one bad mark on every psychiatrist in England, a murder, an assault, or a rape or more than one.

This is Project Psychiatry. We will remove them.

PARLIAMENT & BALNIEL

RETARDED CHILDREN

1. Lord Balniel, being interested mainly in retarded children, aside from any other connection, may have a confusion with a book "Creative Learning", written by LCC teachers, and the work of Ray Kemp and Harry Thompson (a known suppressive person) mixed up with my work in Scientology.

2. In 1957 or '58 Ray Kemp, not then in too good standing with Scientology London, but in no way discouraged by us, taking the book written by two London County Council teachers, was working with UK retarded children groups from a Hampstead Heath HQ of his own.

3. The Book, "Creative Learning", while based on Scientology was written by Silcox and Maynard on their activities in London County Council Schools.

4. Kemp, for one reason or another, got a black eye from those like Balniel who had a vested interest in retarded children, and although he had some remarkable case successes was more or less driven out of the field. His work was badly invalidated to groups interested in retarded children and quite rejected. Balniel's group may have been behind this.

5. Harry Thompson was not a trained Scientology. He moved into East Grinstead while I was in South Africa and worked with two teachers, Miss Snellia Hoad and Miss Roberts. Someone, probably Jones, Clerk of the EG Council, dreamed up the "Death Lessons" scandal of 1961 which made international "anti-Scientology" press. The story claimed the children were being taught to imagine themselves dead. We are not sure why this was a crime as any church does it.

6. It is not a Scientology technique routinely. The publicity was the forced kind of publicity that requires a lot of work by an instigator to get going.

7. So the two largest "anti-Scientology" messes in the UK seem to trace back to retarded children. Balniel is mainly interested in this and it was he who put the recent question in Parliament about an Inquiry into Scientology.

8. All this has several extraordinary features:

(1) Scientology orgs do not work with children, retarded or otherwise, do not accept the sick or treat the insane.

(2) The two scandals came from activities in the UK in no way connected with official or approved Scientology.

(3) I did not write the book which prompted any of these actions.

(4) No org person or org or Scientologist in good standing was involved in either scandal or upset-

(5) The press, uniformly and wholly incorrectly tied it all in to me personally though at the time of the "Death Lesson" scandal I had been out of the UK for months.

(6) Lord Balniel the attacking MP, is interested only in the same subject retarded children, not in general mental health.

(7) All this adds up peculiarly. We are being knocked about for actions we do not do in a field where we do not work by a group which miscalls itself a Mental Health Association whereas it is really only a retarded children activity.

(8) Balniel went out of his own field to attack a group not doing anything he inferred or even in his field of interest.

(9) A closer look at Balniel and his group would probably develop interesting data as it causes trouble (a) for anyone seeking to work in the field of retarded children or children and (b) attacks groups which do not work in this field.

(10) Thus one wonders what is behind all the facade. Anyone interested in working with retarded children is apparently attacked and the retarded children group not only miscalls itself but attacks in the field of mental and spiritual work.

(11) One more datum - there is a "school" somewhere in the vicinity of Saint Hill, worked in by a Robin Harper (1958) last reported in the US but once a UK Scientologist and probably in our Central Files, where the children of famous parents are left while their parents tour. In this school according to Harper who worked there as an attendant, vicious psychiatric techniques are used as a matter of ordinary school discipline and that most of the children had become neurotic or psychotic as a result. This possibly could be connected with the Balniel groups and should be looked up in any investigation of psychiatry. The Jones connection with Balniel should also be looked over. There is something very odd about all this. We should take an interest. Is there some sort of a raid on children going on? There is certainly something peculiar hidden there.

Subject: Public Attacks, Legal Point

It is very interesting that those groups who attack Scientology are consistently erring. The Melbourne Enquiry also erred in the same way.

The PRACTICE of Scientology is today a very routine action. It consists of drills which:

- (1) Better one's ability to communicate
- (2) Gives one the intelligence to handle his problems
- (3) Makes one able to be a social being without committing anti-social acts.
- (4) Brings one to abandon explanations of his failures and to get on with being successful
- (5) Handles all one's reactivity and
- (6) Clears one.

These drills are quite unfrighting. If psychology had them it would use them and be a great success.

On the other hand, the BOOKS and PAPERS of Scientology are a record of research and are writings. They represent a very broad survey of the whole field of human knowledge and the mind and contain ANYTHING THAT WAS FOUND.

The effort is to make these private papers and books seem to be the practice and so make the practice look bizarre which it is not.

Medicine is always noting odd phenomena it finds but never uses in practice. So do many subjects.

Attack on the Practice of Scientology by identifying it with all its research notes is a completely aberrated action.

The books and notes must be available to students. The bulletins which are today used as practice are quite different from the books and notes.

For example, a newspaper group bought research notes stolen from my home this spring. These notes look quite bizarre. But they were not for public issue and are not used in practice. The newspaper group now publishes these notes out of context and implies this is the PRACTICE of Scientology.

The Enquiry in Melbourne used only research notes and never let any practice into evidence and so could make a bizarre picture, particularly as they also condoned perjury in hostile witnesses and would not let friendly witnesses or myself testify.

So the trick used by attackers is to imply that the odd bits found are employed in practice and are the practice.

I am being condemned then for writing up notes and freedom of speech is being challenged.

A survey of current practice of Scientology would show a very sensible and even ordinary looking picture which attains gains for Man he has hoped for but has not hitherto achieved. (1) to (5) above comprise the total practice of Scientology and what its students are taught to do.

1. Before you become too concerned over the current "press" attack, you deserve, as staff, the following confidential data.

2. It is just one paper, the Mail. Other papers won't touch it.

3. The persons involved are just a small handful, less than a dozen, and we know the criminal background and connections of each one.

4. They are engaged in a conspiracy and will soon be brought to book.

5. We have military and defense value, you know, can raise I.Q. in Scientists, shorten reaction time in pilots, improve judgement in troops and undo brainwashing. This makes us a special target and has for years for the country's enemies.

6. The org may make as much as £50,000 out of its suit, which will build a lot of buildings, tax free, so it's not all bad.

7. We are so far from out of favour with governments that New South Wales refused to follow the Victoria lead and will do nothing to hinder us and said so. And we will probably be called in to help on the investigation of Verwoerd's death, particularly as I warned him some months ago.

8. We are probably the only group, church or healing, in this field that refuses to be degraded. Have you ever seen the "Brainwashing Manual"? It was published in the US Congressional Record and explains why we are occasionally targeted - for we won't sell out and refuse all efforts at blackmail. You can have copies of it free if you spread them around town. This authorizes the bookstores to give them away as long as they last.

9. Our current attackers are walking straight in to a minefield. Personal ruin faces each of these few attackers the moment we start our campaign.

10. So don't be worried unduly. We're sitting here with 12 inch howitzers all loaded and ready to fire. Just make sure we do our jobs and in our attack, don't miss.

Subject: Article "E-Meters Replace Guns",
issued this date for general info.

Terrorists and subversives are far more afraid of E-Meters than guns.

An E-Meter is a small, inexpensive box of electronics that ably distinguishes the subversive or the criminal from honest men.

When guns are used on subversives the subversive wins; he wins world support, boycotts, the protests of huge governments. But when E-Meters are used, the subversive loses. He loses his leaders, his communication lines and his support. And even more important he loses his hold of terror over people by which he can cause broad strikes and passive resistance.

The Mau-Mau won after all. Even though he slaughtered thousands of natives in terrorism, the opinion of the world swung toward the "poor native downtrodden by his masters" and Kenya was delivered over to Mau-Mau inspired freedom - and presumably more Mau-Mau massacres.

Subversion is a large subject. Only a skilled expert can handle it.

A good control requires superior technology. Just now the "superior technology" in political use is mental terrorism in subversive and seditious hands. And it is winning in the U.K., throughout the Northern Hemisphere and in Asia. It does not mean freedom. It only talks about it. It means slavery for all, white, brown, and black.

Unless the controlling forces in Africa use technology superior to that in the hands of the terrorist, no amount of guns, no number of soldiers or police can stem the tide.

Police force is an emergency measure. It is vital to bring about order - but only after security technology has failed. That riots occur and that police must act says that security has already broken down.

Unless broad, effective security measures can be instituted, more riots, more police, more terrorism can result.

The average native does not like to run with the terrorists. He would rather live in peace. But when criminal subversives exist amongst the native population, the native is cowed by their terrorism into taking part in demonstrations, strikes and vandalism.

This was the pattern of the Mau-Mau. By threats and enforced oaths, a few trained subversives dominated the area. That the native population was reluctant is demonstrated by the thousands of natives slain by the terrorists, compared to twenty whites.

The terrorist is the proper target of any police action, not the defenceless bodies the terrorist throws upon police guns. The terrorist stays safe while his enforced slaves die.

How does a terrorist subversive accomplish this? His devious ways include blackmail on sex and other crimes, threats of reprisals on families, and promised punishment if the hapless native fails to act.

Guns only shoot the pawns set up by subversives. They do not kill the subversive.

And that is why the E-Meter is far better than guns. It hunts down the shadowy man behind the trouble.

How?

Find one native who participated in a riot or a strike. Put him an E-Meter and without that person saying one word, you can find out made him do it.

Then, finding the person who forced him on and putting that person upon the E-Meter, you can find the man behind him.

The safety of the terrorist is blasted apart the moment an E-Meter applied to some of the people taken from any riot or passive strike.

There is no known way to "beat the E-Meter" used in this fashion at Scientology processing. And in processing honesty and courage returned and the information is usually volunteered. So there is no known way to beat the E-Meter except by smashing it or discrediting it.

The subversive bitterly hates the meter. He hates it so much that upon pro-Russian paper recently devoted half a page calling it "box of rubbish" and other hard names even knowing they would be sued would lose £20,000 at least. It is worth many times £20,000 to subversives to discredit "the magic box".

What is it anyway? It is a very sensitive, extremely modern version of the old Wheatstone Bridge, designed a century ago. Its use has been constantly fought by "liberal" and subversive groups.

An older version exists today as the "skin galvanometer" unit of police lie detector. These machines however are unwieldy and subject to 9% error. Further they cost about £6,000 apiece.

Ten years ago new research was begun on the structure of the machine and improvements were made. Then about four years ago a brilliant electronics team under heavy supervision, designed and built a modern Electrometer.

Many times as sensitive as the police lie detector, this new meter constructed with a very sensitive dial and transistors. It is not subject to mains variations and can be adjusted to read through the reactions of the most nervous subjects.

What does it read? The older models were thought to read "lies". The new model reads emotional reaction and disagreement - and it reads whether the subject talks or not.

The subject is made to hold two electrodes, one in each hand. The operator asks questions. The machine reads the emotional reaction to the questions. Whenever the needle dips a bit the answer is "Maybe". When the needle dips a great deal, the machine is answering "Yes". When the needle does not dip at all, the answer is "No" or "Not Guilty".

The machine also has a tone arm which tells a quicker story. For instance, at a road block, if the subject took the electrodes in hand and the E-Meter was adjusted to read, the tone arm would tell at once whether the person should be questioned further. A tone-arm too high or too low would mark the subject that should be interrogated at length. Sixty persons an hour could be checked by one machine in the hands of one operator by using the tone arm only. And every person with a bad tone arm reading could be set aside for additional testing. All this has held true on tens of thousands of cases.

This compared to the old police lie detector is a great advantage since the old lie detector required about one hour per subject.

The £6,000 detector would require a truck to carry it about. Its new, better grandson is a box not much bigger than a large book.

And what if a person refused to take the electrodes. They almost never refuse even when guilty. But if they did, a gentle placing of the electrodes under the armpits or against the soles of the feet gets the readings.

The E-Meter costs no £6,000. It costs about £36, less than a good rifle. And it gets the right name, not the pawn or the innocent stander.

In troubled times business tends to halt because there has been no way to sort out the dishonest employee, house boy or farm hand. The method used in the past was to remove all the help to a reserve. And that nearly ruined every one and punished the innocent.

A better method is for every manager or householder to have an E-Meter and to understand its operation (it takes about two weeks to become rather expert). Every employee can be checked out at effective intervals and trouble will be caught a long time before it happens, for the instigator of future trouble would instantly be disclosed. It's nice to sleep comfortably and eat and work with no fear.

Subversion attempts to break down the natural affection and understanding that should exist amongst people, between employer and employee. An E-Meter restores confidence. And after all, security is only confidence confirmed.

A whole otherwise loyal population can be turned against its employers and rulers by doing two things:

- (1) By corrupting the worker with lies and threats and
- (2) By provoking the leaders to act savagely toward the governed, thus severing loyalties.

When these two actions are undone, subversion, sedition and terrorism collapse.

All subversion depends on messengers, delivery of arms, collection of monies and other movements. These actions require the use of paths and roads.

By putting road blocks across internal and external paths and highways of the country and equipping these with E-Meters, this necessity of movement is hampered and most communication chains are broken. Subversion could collapse on this alone. For instance there is no reason to unload and inspect trucks when drivers and riders are checked for conspiracy and found "clean".

Constant checking is obviated by thorough checking at regular intervals and issuing certificates of a check, complete with picture and thumb print. A person with "clean hands" does not need continuous checking or special passes. He can be trusted.

Honest people are the victims in a subversion. It is the basic responsibility of a government or an establishment to protect its loyal and honest people.

Make no mistake about the end product of a subversion campaign. The talk during a revolt is all of "liberty", but once the revolt is over, slavery of the cruelest kind is the country's lot. Look at France in the 18th Century. Look at Ghana. It is no kindness to go soft and let a people's lot be worsened.

Around the world today, an enormous raid is in progress. Perhaps capitalism has had some bad points. But capitalism at least returned something for a people's labor.

Socialism and Communism, growing ever stronger in the Northern Hemisphere, are a raid on the production of labor by the privileged few. Socialism and Communism seek to have a people's labor for no return. And the least progress, the least happiness, exist in Communist dominated countries. They "award" the worker with near starvation, no freedoms and total labor.

The reign of terror which ushers in a Communist state in practice never abates. Even when Communism has won "freedom for the worker" there is no freedom - in fact far less freedom than ever before. So no effective measure that halts the sweep of terrorism should be left unused. So have no qualms about the invasion of privacy factor in using E-Meters. Only the honest deserve privacy. Only the loyal have earned it.

And yet we often hear honest men revile the use of quiet interrogation. They are misguided. They have been set on by dishonest men who are trying to hide. Only the honest have rights. It's a good thing to remember that when subversion is about.

The E-Meter prevents the honest from being arrested, jailed, martyred. The punishment of the honest is all music to the terrorists' ears and earns a large splash in world news. So prevention of injustice is vital.

It is remarkable that the E-Meter makes it unnecessary to jail men for political crimes. And this punishment of political action is what makes bad press in the United States and England.

How is that?

Political crimes of the intensity of mob violence, terrorism and vandalism occur against the background of a very odd fact: the professional subversive is held on the job by blackmail. The blackmail consists of threatened exposure of an actual criminal background.

In a very large number of cases checked on the E-Meter it was discovered that the majority of persons guilty of political crimes were first guilty of actual crimes such as robbery, murder, rape and mayhem. Of a long series of known Communists checked out, the large majority were found to have committed crimes of violence.

In the light of this startling fact, jailing a person for political beliefs or sedition becomes relatively unnecessary. One doesn't jail a murderer for inciting a riot and incur vast international press repercussions. One jails a murderer for murder and hangs him very thoroughly.

A country can be torn asunder by failing to understand subversion. A government becomes savage, driven half-mad and understandably so. It cannot find anything to hit except its people. Employer becomes paranoid about his employees. Which one of them will cut his throat? And understandably he becomes hostile to all of them. The worker feels the brunt of government and foreman and, afraid, has no place to turn and comes at last under the executioners axe of the terrorist as he mounts to power or grinds out his life, a slave in the donkey mill of the "new peoples state."

The forces of subversion loose on Earth today use exact technologies. These are taught carefully to criminals in prison, in schools, in foreign states. This is the new psychosis of Earth. To break it one need only work with truth and reach men's minds with Truth. One need but be certain to have the subversives behind bars, or otherwise scared for, to prevent truth from being corrupted. And the E-Meter singles them easily out from the loyal crowd.

No fortress, business or country can long endure in the climate of hate.

No gate, no fortress is more secure than its garrison. That corrupted and why the walls?

Not for nothing does any "new peoples state" shoot down the moment it's in power the very men who destroyed the old. Counter-revolution is the terror bedmate of all new Communist states. They know how easily it is done and how. And so they usually remove even their own old agents by the firing squad or through exile. The Trotskyes don't live long. Therefore, if this is so efficient, why don't we remove the agents now before the peoples state is formed by violence? We don't even need to know their names and addresses typed on a neat list. Those can be found by a quiet dial placed in the hands of any rioter or striker that is caught. These wouldn't talk. They don't have to. The meter does the talking, even in semi-skilled hands.

Reform of abuses in a state cannot be achieved while that state is filled with distrust and nerves. And a state will be so filled while subversives, trained in their own technologies, are still at large amongst a people.

Confidence is the only atmosphere in which reforms can take place.

The subversives in the U.N. and throughout the Northern Hemisphere have South Africa now just where they want her. Antagonized by violence within her borders, South Africa uses guns. The subversives through the world screen and cause, by this, good people to act and protest.

The end of this tragedy would be a South Africa denied all help, even arms, shut off to the North by "new peoples states" well supplied with arms, and finally attacked from without only to collapse from within by carefully prepared revolts.

To turn this into a comedy, with the subversive at the receiving end of the joke is not hard to do. A populace of Asians and natives loyal to South Africa could help fight subversives rather than aid the collapse and any war declared in the north could be rolled back with ease.

To accomplish this at first not even government cooperation is necessary to the project. If employers and householders could read men's minds with the "the magic box", they could assemble to themselves loyal crews. If this were broadly done the government would soon follow suit, at only to the extent of the individual police members adopting the method to save themselves hot work in interrogation and arrests. But let us hope the government as well would quickly avail itself of technology superior to that of the subversive and quickly run subversion down with modern scientific technology instead of tedious and ancient actions which, everywhere they have been used, failed.

E-meters are cheap. They can be imported in enormous quantities. They are easy to operate. Special evening classes could be set up quickly in existing centres throughout South Africa. There are no frailties or bugs in the modern meter. They read positively. The E-Meter and the know-how to use them is fifty years ahead of the technology being used by subversives. And if the terrorists learn it, they cannot use it against South Africa because it is the technology of honest men. To use it is to become honest.

Although the E-meter technology now extant and well known to certain skilled persons in South Africa could be adequate, some additional technical work should be done to speed the resolution of this particular problem. Coordination of the programme and compiling instruction leaflets for the layman also should be done. Not even this is needed to launch the programme but the effectiveness of the action could be speeded even more if it were. There would be no substitute for having a top flight security expert on the ground. Unfortunately those present, through no fault of their own, lacking technology, have already failed.

Once subversion is handled and terrorists put out of the way, continued use of this activity would prevent further occurrences. Thus a re-checking of employees and population at intervals would be necessary to maintain peace.

And peace with trust is the only atmosphere in which measures can be taken to bring greater understanding and participation to a populace.

A government cannot compromise or quit under duress without losing its strength and vitality. One cannot give up his integrity just because he is threatened. But once peace with trust is secured, harsh and inhumane methods of handling people become stupid and can be discarded.

Only by treating its situation sensibly and effectively can South Africa live through the tremendous external pressure of a world gone mad with slavery in a new and terrible form.

It think the world outside South Africa is free. It is not. Lying deeper and deeper into the slavery of new economic tank- of rapacious governments, of its own terrible weapons.

South Africa and Australia may well be the only civilized countries will survive a coming atomic war. Thus South Africa has a responsibility to keep civilization alive and a population "peoples dictatorships".

South Africa needs every bit of modern technology it can obtain enough to security.

South Africa faces today these menaces:

exerted and concentrated technology of the terrorists which has far won everywhere it has been hard tried - i.e. Kenya, Ghana, UAR, etc;

possible shut-off of arms - i.e. Batista in Cuba;

atomic boycotts in the hands of rabble rousers running free and unopposed in the Northern Hemisphere - i.e. recent boycotts in London;

world press, fattened by new riots, a press that forgives any terrorism if anyone seeks to keep order and uses guns - i.e. inciting, hanging riots;

people's states just to the north, ready and able to supply subversives, unlimited arms and eventual war with the wholehearted support of the world - i.e. Egypt, Algeria, etc.

general distrust which can rise to stop all productions - i.e. Russia, etc.

ever more divided government as the government seeks to hammer home the threat by needful methods which yet dismay the hearts of every decent man;

engulfing of white, Indian and black alike in the chaos calamitously created by a handful of trained subversives.

There is no time to leave stones unturned. This is no time to fail and apply the best available technology and the most effective

RE LIFE ARTICLE AND LETTER

It is interesting that "Life" Magazine in the US has been a violent foe of Dianetics and Sca for 18 years.

Their connection to the enemy is not yet established. But it certainly exists.

In their letters to the editor in their issue of 6 Dec 68 they made a very fatal error. They published and signed my name to a letter I never wrote them, which makes them guilty of forgery, doesn't it.

In England the heads of the largest newspaper chain are also members of the UK World Federation of Mental Health confederate board of directors.

This is an old intelligence trick — to own or control a press chain in an enemy country.

It was done by German agents, for instance, to keep Spain out of the war.

Earlier the "Saturday Evening Post" published an article full of quotes never made. It has gone downhill as a magazine over the years. WFMH connected publishers often do. So there's another one.

So some of the US magazine and newspaper chains are controlled by the WFMH.

They keep a continual flow of anti-Scientology handouts going to all magazines and governments.

The Intelligence, espionage pattern is very plain here. In the "Life" article a psychotic is pushed into the org to get no case gain, his identity secret, to get discreditable data and he then writes an article. But he is already a mental patient.

Our Documents and files are often found in enemy hands. And now and then at SH or an org we find a lock smashed or a window broken.

Local Agents WFMH has confederates (we call "Black Hats") in every country and many states with sub-chapters in most US cities.

They are always named "National" and have "Mental Health" in their name at nation or state level.

There is a "National Institute of Mental Health" in Washington DC that is US government. The only one in the world really connected to a government. It does WFMH printing for it at US expense!

All the rest of the "National" groups are phonies. They are only private groups, following orders from overseas.

In every US community, almost, local branch groups (such as Federal Mental Health etc as a sample) belong to the private "National" Group.

These small town groups are advertised as "local housewives" etc. But in fact are often composed of ex institutional inmates, brainwashed, ready to stir it up into "public" for WFMH. There is even one in East Grinstead.

These local groups may be what gives orgs trouble with Councils etc.

They always have "mental hygiene" in their name or "mental hygiene" as unchanged from an old form they use.

These groups secretly shoot an antiopracitors, churches, any Western culture or advance or healing action.

The standard propaganda line is (a) everyone is insane

(b) psychiatrists should be next to every world leader treating them weekly.

(c) Anyone should be subject to seizure as insane without process as law (a "Siberia" bill they seek to get passed and which once almost did pass through Congress.)

(d) Scientology breaks up families.

(e) Scientology prevents people from coming to their psychiatrist to seek real help.

(f) There are not enough psychiatrists or "facilities".

(g) All boundaries should be destroyed.

(h) All constitutions should be destroyed.

(i) Any current campaign they may have to get something destroyed for a big Western take over.

They are currently shipping insane people out for "community care". They drive them hopelessly insane in an institution and then push them out in the community to make trouble.

Every major assassin has (1) seen a member of WFMH before the assassination and (2) been defended by a member of WFMH after the act if still alive.

Even the press (that of it not owned by WFMH and some that is!) has begun to establish that the attacks on Sen smell to high heaven.

A conspiracy formed at the WFMH Congress in London in August 1968 resulted in simultaneous identical political channel attacks on Sen in several countries.

The "Life" article was crudely timed to be part of this.

The "letters to the Editor" also contain a typically enemy colour and campaign note such as a disconnected family named "Fridkin".

It would be wise to use police re WFMH if quarters are broken into, etc. But this is not foolproof as psychiatrists are group training California police not to break up riots.

Staff level you need not make any profession of smashing

WFMH as we have it going hot at the top and they are ducking.

But in answering questions about such articles you can say what you please.

And every branch of every rightest group would be delighted to know these US "mental health" groups are controlled by a foreign group which has Communists on its board of directors.

Chiropractors etc would also be delighted to know who has been shooting.

The American Medical Association and the American Psychiatric Association and such are members of the main world group and are just pawns.

WFMH is also incorporated in Delaware with a board different from its advertised board.

At least one member of the Delaware board is a Communist, I believe, at least the name is the same as one hit by the Congress on American activities committee.

The thing to realize about all this is that the acts of this group are often criminal in nature and they can be hit for it.

It's really a wild organization. They are called "Mental Healing" but their literature talks only about world domination and seldom about any cases.

They make big crashing mistakes such as saying they are part of the UN when they are not.

Such as committing crimes of burglary

Such as murdering mental patients and calling it treatment.

They just make big mistakes.

They were founded by a psychotic named Clifford Beers and carry on the tradition. How would you like to run an organization composed of psychotics and psychiatrists? Be nearly impossible. So they are very frail indeed so can be obliterated successfully.

But the biggest mistake of all was hitting Dianetics and Scientology from under cover for 18 years. We weren't even in their line of country.

The public in effect takes little heed of articles or press. Hardly anybody read the "Life" article. Who reads a dead mag.

But the "letter from me" which I didn't write is typical of WFMH Forgery..

It is interesting that WFMH says publicly there is "no difference between right and wrong" and "psychiatrists are the only enlightened people who know this".

By traditional law, sanity is defined as the "ability to tell right from wrong."

Enough said?

Western Countries

One has to ask a question seriously concerning the American-European-Anzo world - normally called "The West".

Are they capable of surviving?

The business of police is public safety, which in any terminology means the personal safety of the person and the goods of the individual or group.

In any governed society the government takes responsibility for personal security.

If the government itself aids and abets the actions of criminals, condones or legalizes raids upon possessions and attacks on the person, then it is no longer a government but a hostile enemy of the people.

When a government collects taxes it is supposed to give service. When it collects taxes and turns any part of them over to those who attack the people to assist the attack on them and provides no protection in return then it has ceased to be a government and is a kind of curse, like a locust swarm or a plague.

If protection was proportionate to taxes and was actually furnished, even then there would be no real complaint even if the taxes were high.

The definition by Classic International Law, determining a Sovereign Power is "the ability to protect the lands and people of the country from foreign aggression." If the government cannot or does not do this it is then, in International Courts, no longer defined as the Sovereign Power of the state.

Modern governments realize they cannot defend their land against atomic bombs (as there is no defence) and since 1950 when Russia stole the formula of fission have degenerated into the shadow of the real government.

Western governments and peoples are under ceaseless and unrelenting attack from the Communist forces in the "cold war". The enemy has for a long time been inside, getting laws passed, degrading the society, seizing persons in the name of "psychiatry", pushing up taxes, inflating money.

Well it's pretty obvious what the enemy is doing.

But if this is so — and we know now it is — then where are the Western governments? Where are their OOs and Steeds of "Avenger fame". Where, even, are their pavement pounders.

SH suffers a small crime in the average of once a month — theft or breaking in. Out of this long list, not one crime has ever been solved by the police to whom each was reported. SH on the other hand has solved several of these on its own. Interesting statistic isn't it?

Over the years we have had a lot of crimes against us in orgs in various countries — petty theft, etc. And even staff members injured and killed in LA and DC years ago. And where were the police?

The enemy in '63 dressed up Baltimore longshoremen (the enemy recruits in labour unions for members) gave them guns and badges and they raided our DC HQ and seized everything they could grab. These were called "Federal Marshals" in the press.

We have had a lot of action by police and governments against us WITH NO EVIDENCE OF CRIMES BUT LOTS OF EVIDENCE OF DOING GOOD but we have not had ANY protection of any kind.

The orders the governments followed in attacking us were originated by KEDS, by the 'usually foreign' psychiatrist, operating as per Communist instructions to destroy all Churches and Scientology in particular.

The governments took THEIR orders. We were citizens of the country with honourable decent records and intentions.

So where were the governments? Where were the police?

We in desperation, conceiving that the society appeared lawless, developed our own codes of justice and our own ethics officers.

SINCE THAT TIME WE HAVE MADE HEADWAY.

Not only that, we have also found the enemy and have him badly rattled.

So, the point is, if this handful of us could accomplish all that and stay alive and grow as well, and if the governments concerned could not handle it and were themselves being moved down and turned against their own people, we came to two conclusions.

A. We are largely on our own.

B. On our own we can make steady progress.

This then leads to the conclusions that

1. We must be an awfully effective group

2. And, wildly enough, we are better than the continued governments of the West in defense from Red attacks.

All right, those are fantastic conclusions. But they add up to that by all processes of reasoning.

This is no bid to revolution. It's just a summary of bald facts.

We, the dark horse, came up from the dusty rear of the field and got about 100 furlongs ahead.

So who are these other guys? The police and the governments? They were obviously the losers in this cold war. They couldn't win on the battlefield or in the conference chamber and they not only let the side down, they helped the enemy.

Either the police were tied down by the corruption in politics or they didn't care.

I think we ought to give policemen a piece of our mind.

What are they doing letting their citizens be chopped up?

The job we're doing is their job. They get paid for it.

Sooner or later one of two things happen in a state:

(a) The people and government get tired and the whole thing folds up, or

(b) The people start siding with the winner against the government.

We didn't set out to be a political force. We don't care to be one.

BUT WE ARE BEING FORCED INTO TAKING RESPONSIBILITY FOR THE WEST.

Wow.

Assistant Guardians here and there at the peak of the late 1963 enemy offensive, were getting calls from unions and public groups TO ASK FOR HELP OR DIRECTION in handling the local government on matters of their own, not ours.

At the beginning of a government...

The people are on our side in these weak states.

Now in a governed area that is newly or strongly governed we are being included and welcomed by the new government.

We didn't promote any of this, really.

The people of Western nations would rather die than become puppets in a Communist state. They do not have much faith in their losing governments.

As we were an unsuspecting object of attack by the enemy we had to measure up to it or die as a group.

We measured up to it. We did not die, we expanded.

So now what happens? We are caught up in world forces. The West is losing steadily as governments.

We refuse to be a revolutionary force. We will continue to try to cooperate with the West.

But it looks to me that this is what will be forced into existence:

As we totally dominate the technology of the mind, as we are winning where the West was losing, as Western governments turned on us and were thereby shown to be weak or corrupt, the public as the years roll on will force us into a position of control of order whether we like it or not.

That's the way the tide is swinging.

We have a lot of hard battles ahead, I am sure. We will have to be careful not to be classed as a revolutionary force. We will have to keep our truth and integrity in the face of all opposition and carry on and continue to win.

And just by doing what we are doing, I predict that the West will survive and that Communism will succumb. And that we will make our target of a cleared 4th Dynamic.

If we really keep on working hard at our jobs.

Good News

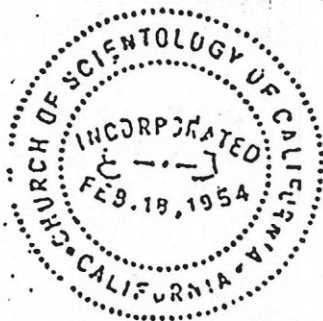

As you would expect, the intensity of attack on Scientology is at its greatest in the Australian, New Zealand area.

I have been studying the subject of modern government. As you know I was trained in this subject (in one of the Universities the reporters say I never went to).

Nearly every major country in the "free" world has been sporadically at war, by which I mean guns and soldiers, in one place or another since 1945.

Only one country has not. That is Russia. Her 2,000,000 man army, amongst all major armies, has only had two brief actions - Hungary and Czechoslovakia. Instead she engages in guerrilla support or insurgency attacks by local partisans over the world. She is engaged in this and continual propaganda attacks. By this she has kept in action all other major armies serving as "security forces", in "brush fire wars" or revolts.

Obviously the lesson is plain. To defend an area one must attack.

All other major nations are fighting within their own territories or on those of allies. They are fighting on their own soil or that of allies. They are losing. There isn't a ripple in the Russian homeland.

So in this universe the winning tactic must be to attack. The losing tactic must be to only defend.

These "brush wars" are inflating the funds of rather extravagant western powers. It cost France £1 million a day to combat (and lose to) guerrilla forces in Algeria. It is costing the US \$40 billion to \$50 billion a year to "police" Vietnam. That was the total national budget a few years ago! Thus Russia is wrecking western currency and economics as well.

But the main thing I have scouted out is that these guerrillas or insurgency forces who start these "brush wars" have to have a powerful cause. It has to be powerful enough to attract large portions of the local population.

The "free" world invalidates these insurgent causes. But a cause great enough to bear one's breast to western machine guns, to starve and die for, must be quite a cause.

If such a cause can generate such local support and eventually win over whole populations, then it must be founded on real, not imaginary, abuses.

No guerrilla force agitator can build total support with empty slogans. There has to be sound solid reasons that each supporting member of the population can know for truth out of his own personal experience.

So there have to be abuses on the part of the governing forces. There must have been abuses for a long time. And nobody in the government did anything about them. And so, slogans, lies or no lies, there had to be real factual abuses enough to bring about revolution.

misdeed, we have been ridiculed, mocked, fought and knocked around by our governments who followed the orders of the pressure groups.

So these Western governments are capable of gross abuses. Governments that attack writers, religions, peaceful social groups are never long for this world. When they attack Scientology, the highest level of mental tech on the planet, and actively support and finance the sordid seizure, torture and death of psychiatric victims they must be utterly mad themselves.

So what's this cause they offer? Some insurgent group comes up with any cause at all and the population goes for it.

The law on this is that WHEN Faced with a corrupt and oppressive government, the population tends to join any group which that government attacks without even asking for what the attacked group stands.

In other words they are all being attacked so they identify themselves with anyone else being attacked.

If the attacked group has shown spirit and defiance and attacked the government in its turn you then have a revolution.

Those are the crude mathematics of revolution.

As oppressive governments have no real cause anyone that anyone would really fight for (who wants to protect the puppets of a corrupt pressure group?) then any popular insurgent cause is adequate to rally a population.

Our problem then is to refuse utterly to be forced into the position of revolutionaries. It is hard to do.

Somehow we must get these governments to clean up their own houses before they are carried down by the outraged mob. The end of that would be complete chaos.

The main area where they err is in attacking their own people. Justice is not for the poor. Any false report by any of these depraved pressure groups can get any individual or group into severe trouble. It costs vast sums of money to defend in modern courts. The average person does not have it. Therefore human rights must be made a fact, not an idealistic dream.

The very basis of human rights is freedom from false accusations and from brutality and punishment without offense.

Somehow, government by prejudice and false report must end in the West or the West itself will end.

By bringing about real human rights, perhaps there would be enough cause in the West to be worth fighting for.

Somehow society in the West must be revitalized after decades of arduous degradation.

It will not be an easy feat. It is very hard to save a being or government who is bent whole-heartedly on self-destruction.

We are trying to get these governments to clean up their own houses and so preserve themselves.

We are trying to get the society to revitalize after decades in the mind of decayed animalism.

It's a large order. But remember this, if we do not succeed then it is the end of the free "world" and the probable end of everything we know of Western civilization.

On the other hand there are social groups and people without count who, given liaison with one another and a uniting of their spheres of influence, will help us.

We must try very hard to wipe out these attacks on us and refuse steadfastly to be forced into a revolutionary activity or into the arms of insurgents organizing even now to destroy every government in the West.

If we, with no crimes on our hands, can be remorselessly attacked, if the bad hats only are protected and their crimes ignored, then we have a gauge of the task before us.

We are already reversing this trend.

We do have a chance of succeeding all the way. We are the only group in the West that is standing its ground and winning.

I have put in quite a lot of intensive study in the last few months on the character and anatomy of the opposition. And I have found some amazing phenomena.

Evidently what seems to be going on on a very broad basis in the West is a social evolution that is not pretty.

Russia apparently "won" World War II. She acquired 750,000,000 new population in conquered areas. The West betrayed the expatriate governments of these seized countries (Poland, China, Czechoslovakia etc) and the crime has come home to haunt them. The West finally woke up to the fact it had an enemy not an ally.

The continual cold war needling of Russia has pressured certain elements in Western governments into TURNING FASCIST.

The natural conflict of Communism and Fascism has been pressed into being in some areas in some Western governments.

Fascism is "Industry operating in collusion with the military" according to the text books.

A Fascist has certain personality traits. He tries to obliterate minorities. He burns books. He seeks "legal" means to seize any person who disagrees and hold or murder him. He does physical experiments on people.

The Fascist has the delusion that ideas can be crushed by force.

Such small elements in Western governments have turned to the psychiatrist as a method of seizing, torturing and killing people. In the US Civil Defense Manuals under "Psychology" it says the role is to notice anyone who tries to do anything about a nuclear bombing or who is blaming the government and seize him and put him in a stockade. No mention of soothing the population or caring for emotional upset is made.

These fascist elements were looked to to resist Communism and so have gained some power. They probably don't even think of themselves as anything but "patriots".

The Communist elements are infiltrating such areas and attacking such officials heavily.

The Western population is overwhelmingly on the side of human rights, so these politicians are against the stream of public opinion.

If the Communists can force these fascist elements to act against public opinion (such as attacking Scientology and other minorities) they can show the public that their government has a cause worth fighting for, that it is destructive and mad.

This effectively turns the people against their own governments.

It is a vital consideration (according to all their literature) that an insurgent must be able to operate freely amongst the people without being informed on or given over to authorities. If the government by doing crazy and unpopular things (such as attack innocent people) it will become distrusted and detested and a Communist insurgent will find support among the people.

The stage is then set for Communist insurgency and government overthrow.

The odd picture then greets us when we suspect our enemies, of a fascist inner-government clique with Communists mixed up in it.

The Fascists, lied to and needled by Communist elements then act like mad dogs against the wrong targets in the society, become hated by the public and no longer find public support or obedience. The Communist is then able to subvert the entire country by propaganda or insurgency.

Right now the fantastic desertion role of Western troops shows they do not support their own governments. When the show down comes, possibly it will be another 14 July 1789 when on "Bastille Day" the National Guard of France turned at once to the side of the people. And for some years the heads of the "best people" (meaning the fascists of that day) rolled into baskets.

People do NOT ask what the revolutionary is going to do. That he is overthrowing a hated government is enough to keep the public uncooperative at best or in active revolt.

The causes of revolt are unpopular unfair and brutal government punishment and actions and oppressive taxation, plus some element active in promoting revolt.

Julian Paget's "Counter Insurgency Campaigning" Faber and Faber, 24 Russell Sq., London, and James Eliot Cross's "Conflict in the Shadows", Constable and Co Ltd., London, are two excellent recent books on Communist activities and Insurgency over the world. I wish politicians would read them.

Communists are not attacking us. They are stirring Fascist elements up so they will attack us.

This involved action then causes the Fascist to look crazy. He is seen to be attacking a minority church group which has done nothing, causes him to seize innocent books and generally act like a Fascist.

The people see these acts as wrong headed and the government loses credit.

Thus, when we investigate these actions we find fascists running death camps and commies stirring it up.

It is a pretty dizzy sort of scene.

For 19 years we have been demonstrating that we help people and have the first truly effective mental technology. If we won probably both the Fascist and the Communist would lose out since both are fanatics.

Remember that we are not the only ones being attacked. So the cumulative effect of their attacks makes the Fascist "prove" to the population there is no good reason to defend "such a Government" and every reason to knock it down.

By deteriorating the government's cause the potential revolutionary can greatly improve his cause. And one day the government goes to pieces. In the ensuing commotion the Fascist feels he can take over.

Not every militaristic government is a fascist government. Far from it. Militarism is a condition, not an ideology. In self defense several nations have shifted over to militarism to defend themselves against all this confusion. Having done so they feel more secure. On the other hand Fascism is a very particular frame of mind - oppress minorities, burn books, seize torture and kill people on some flimsy pretext, fatten the industrialist by heavy government expenditures, these are the primary characteristics of Fascism. But above all it believes all ideas can be fought with force and only force. Getting a better idea or strengthening their own Cause so that it will appeal to their people is seldom done by Fascists. At best they seek some new foe to distract their people.

Fascism is too old hat. It won't wear.

Our opponents are a small clique running against the trend of the world. They will lose.

I've been studying the state of psychiatry and there can now be no doubt whatever that their "treatment" is political treatment and should be called such.

Electric shocks if not given show patients would leave 6 weeks earlier.

Brain "operations" result in total loss of body coordination and a bright normal being is turned into a drooling blob of flesh, unable even to retain urine. They live only briefly when they do not die at once on the operating table.

The only precedent for such "operations" is Hitler's action in doing it much more lightly to 800,000 persons to make "farm slavery" or zombies.

The political colour command and control of parliaments and legislatures by psychiatry are evident in the easy seizure without trial laws being passed or in the hypocritical actions like Ronald Reagan's new bill in California that was hailed in the press as giving "rights" to patients in asylums (comparable to Geneva's Prisoner of War Code) to refuse such treatment but the actual bill says in small print that the "doctor" can refuse any of these rights at his sole discretion. This equals a sentence to death without trial or even a crime.

In Dianetics insanity is shown to be common physical illnesses, yet asylums have no medical facilities. Dianetics can handle insanity with relative ease once the physical injuries and illnesses of the patient are cured medically or when the patient is only lightly ill. A new break through on this is now being taught real M.D.s in England by a team I trained.

So there is an easy cure of insanity in ordinary medical treatment of broken badly healed bones, bad kidneys etc plus easy Dianetic auditing.

Dianetics has been available and proven for 20 years. Yet psychiatric front groups have been able to command sufficient political action to prevent its use, instead getting bills passed to easily seize anyone, torture and kill him.

Thus the Western countries are seen to refuse actual treatment and legalize inhuman torture and brutality.

Psychiatric treatment is actually psychiatric political treatment, nothing more, to rid the world of anyone who might disagree.

Nelson Rockefeller's "youth stockades" are for youths who might become delinquent, it says right there in the founding papers.

In Arizona Federal judges sentence delinquents to electric shock or death for "being turbulative".

Insanity is now defined as anyone who disagrees with the social autonomy.

The handwriting is plain. Only the government supports psychiatry. The public by and large stays thoroughly away from them. Death

as like the one just found in Cardiff are situated strategically in the West. Hitler at least wasn't pretending to help anyone. He wanted them dead.

So psychiatric activities consist of Political Treatment. That's very certain now.

This was the deadly secret we in Scientology might have found and which made them terrified of us, ridicule us, fight us and spend over 2 million dollars to try unsuccessfully to get rid of us.

Over the world they were running death camps.

A few times they missed and certain political actions came to light - Ezra Pound the Poet, Governor Long of Louisiana, General Barker of Little Rock, managed to become known about before they were de-personalized.

If we can expose and eradicate this bestial tendency in Western government before it is too late, the society will not fall into the chaos desired for a Communist take over. It's our one chance. Use them fully and fast.

If we delay, the mobs will tear these government leaders limb for limb for other causes than political treatments.

If exponents of death camps can be gotten out, Western governments may yet survive.

Remember that Pavlov 1870 and Wundt 1879 invented these technologies and every nation that used their work - Russia, Austria, Germany, Poland, has ceased to exist, their leaders brutally slain and the governments replaced by maniacs. So it is no idle prediction that the West, using now Wundt and Pavlov, are very close in their march to going down in flames.

Man just doesn't like being called an animal or treated like an animal. He revolts.

Extracts from an LRM Communication.

'The enemy is stuck in a situation estimate that is probably circa 1958 and has never improved. He's working on a preconceived campaign 12 years out of date. He doesn't get intelligence, his info centre isn't getting any data - they are probably running on press clippings.

'They started in the furthest corner of the world. They got Australia kicked in the head, they think; SA will go, they think; UK will go, they think; in the US he will kick up a screaming storm using these other Enquiries - he thinks - and he thinks we will be wiped out. He has done his think and he doesn't even keep a check on it. A mindless wonder.

'He has an action service, but no reporting service. He has no central intelligence collecting activity because he's not an intelligence organization.

'So that is their master plan!

'His situation analysis is out of date and he's lost many of his old hands. Yet he's still talking about how he has wiped them out and it is all going according to schedule.

'It's something like a crazy hunter who would go out to hunt tigers. He'd manage to drive the tigers towards the edge of the wood and ever since he's been talking about how he wiped out all tigers - while there are tigers walking in the back door.

'He substitutes his desire for the fact of it.

'It is a totally failed campaign which is twisting in his hand. All he has done is give us international publicity.

'There will be a heavy attack in the US and it will give us a lot of trouble. But it won't play the way he thinks it will play. Basically it is the Guardians Office that has turned this.

'The only way we can lose is by being inefficient and taking our finger off our number.

'I think personally he'll lose it in SA and in England. But that only includes us being very good. We've got an awful lot to recover from.

'I have a new system to knock them out no matter what they do.

'We started telling them to investigate newspaper reporters who wrote against us - a lot of them bribed, freelancers bought, a lot of officials on this line. Had to figure out how to hurt those guys and still stay legal. They have a vulnerability already worked - several guys have lost their jobs over this. How could they be hurt - all you have to do is spot it, figure out how to cost them their jobs and make them lose it.

'We have some trouble getting the real background dope on those guys but they do pick up what the guy is doing in present time. So we change the procedure to spot it and cost them their jobs every time.

'This is another piece of tech - attack always comes from an individual, not from a group.

'We could do this with some Minister of Health in contact who is pushing for a ban.

'They are in the business of destroying our reputation over the world - that is their overt on which they work - the motivator.

'In SA Enquiry - the Commission's lawyer admitted to having
 d the Melbourne Enquiry Evidence in his Testimony. Three of
 members of the Commission are people who instigated the attack
 the first place to protect themselves. So it is an invalid

 a state of the first reciprocal and it won't be in any other
 te than the first reciprocal.

'He is just a plain ordinary garden variety sitting duck.
 can be hit by any changed tactic without ever knowing that it
 been changed. Note how often I change my tactics.

'Freedom went back on defense - staged events of defense
 I didn't get a line of press.

'There is a misdefinition of attack. They'll lose ground

'Jane should take defensive action and go ahead and mop
 the enemy.

'The reason why Gdn's Office hasn't go into the defensive
 that it is handling a reactive line. "Attack" is common to

 'It is very easy to get a whole bunch of people on attack.

'The Guardian's Office can go the other of attack any

'We should continue our attack line and become even more creative in our attacks.

'Does Mo receive a great deal of clippings on psychiatry which you can use attacking? I find that one can get the best of attacks going by using their own material back at them. Their books, articles, news releases - are frequently and most cases 100% usable.

'Anyway, let's hot it up.'

THE PSYCHIATRIST AT WORK

Auditors are often fought by psychiatry. The auditor is often called upon to handle psychiatric abuses. Auditors should know some facts about psychiatry.

PAIN ASSOCIATION

As a technical action, it is of interest to any auditor to know that Pain and Ideas is a basic "therapy" used down the years by psychiatrists and such lot.

The practice is very general and very old.

The person is made to associate his "wrong ideas" with pain so that he "will not have these ideas", or will be "prevented from doing those things".

A crude current example is to electric shock a person every time he smokes a cigarette. After several "treatments" he is supposed to associate the pain with the idea and so "give up smoking".

Homosexual tendencies are also so "treated".

In earlier times alcoholism was "cured" by putting poison in drinks so drinking would make the person violently ill so he would "stop it".

Examples of this are all over the time track.

The mechanism is "If you get this idea you will feel this pain" ZAP!

Basically this is the action of an implanter.

Current use of it will be encountered where psychiatry has been busy implanting.

This is a pinnacle, an all, of psychiatric "treatment".

Another version of it is drugs. Make the person too torpid (sluggish) to have any ideas. The motto of this is "too dead to act". Institutions are emptied by hooking psychotics and "community psychiatry" exists "to make them take their pills", in short, to keep them hooked. This started the current drug craze that spread into "illegal" drugs.

The auditor will encounter this with growing frequency as the business of it is so big that one group spends 12 billion in advertising alone per year! This is the Rockefeller drug cartel. They also spend vast sums in lobbying parliaments.

OBSESSION

Most "got to's" or obsessions come from Pain Association or drug association.

People in pain or drugged can become obsessed with doing the idea.

What the psychiatrist does not care to publicize is that his "cures" are implantings with compulsive ideas.

The smoker so treated now MUST smoke but CAN'T smoke. These two things are opposed. That is known as frustration - a form of insanity.

Must reach can't reach, must withdraw can't withdraw is total basic insanity.

Thus psychiatry is making insane people.

This is why the insanity statistic is soaring and why the crime statistic is on a wild climb.

The psychiatrist if he handled his field well and did really effective work would have a declining insanity and crime statistic.

That the psychiatrist and his "technology" has been in charge during the whole period of these alarming statistics is ignored by governments.

The psychiatrist argues that he needs more money and more practitioners. But he gets money by the billion. The state has to totally support them because the public will have nothing to do with them.

Psychiatric care in a private hospital costs \$30,000. \$2,000 a month for board only is the price at Walnut Lodge in Washington DC, an average place. £60 a week is charged in England for a shabby room. "Care" is extra if it exists.

Psychoanalysis costs £9,000 for a full and ineffective course, takes 5 years, 30% suicide in the first 3 months.

Psychiatric treatment runs 5 times the total cost of every course, grade and action available in Scientology.orgs.

SKILL LEVEL

Any RAS knows more and can do more about the mind than any psychiatrist.

There is no real level of comparison since psychiatry as used is a destructive technology.

Under a "drug treatment" engram you often find savage electric shock of execution strength buried.

It is doubtful if one could watch an electric shock "treatment" without vomiting.

In "neurosurgery" the Ice Pick is used to rip and tear up peoples brains.

Holes are drilled in skulls and the brain sliced up.

No evidence exists that this ever helped anyone but it makes incurable invalids.

Illegal seizure of anyone and his torture is legal in most "civilized countries".

MASTERS

The psychiatrist has masters. His principle organization, World Federation of Mental Health, and its members, the National Associations of Mental Health, the "American" Psychiatric Association and the "American" Psychological Association are directly connected to Russia.

Even the British Broadcasting Company has stated that psychiatry and the KGB (Russian Secret Police) operate in direct collusion.

A member of the WMEF sits on every major "Advisory Council" of the UK government, to name one government.

Ministers of Health or Health Authorities are members of the National Association or the WMEF.

The psychiatrist has masters.

DOCUMENTATION

All these statements are the subject of total documentation in the hands of Scientology.

SUMMARY

The auditor in auditing uncovers considerable data in former psychiatric cases.

Further an auditor can put to rights a case so abused unless a fatal injury has been done.

As psychiatry circulates rumours about auditors and attempts to discourage the use of Dianetics and Scientology, it is only fair for the auditor to know exactly the status of psychiatry and psychology as used today.

It goes without saying that the savagery and fraud of psychiatry must cease and that auditors must encourage in state and public and through all his connections displacing psychiatric abuses with sane auditing.

RE: BOOKS & ENTHETA WRITTEN ABOUT SCIENTOLOGYBY SPS

In the UK, the following legal actions have been done on entheta books which have been written about Scientology.

1. Satan's Slaves - this was a book all about Charles Manson and his cult in California. In several places, throughout the book, Charles Manson was mentioned as a former Scientologist (untrue) and it was alleged that he got his start with Scientology etc.

The publishers of the book were sued for libel -- they did not serve a defence but instead asked for settlement. It was agreed that they would pay us £100 damages, together with the costs of the action. They also agreed to make an apology in open court and to discontinue publication and sales of the book.

2. A psychologist by the name of Dr. Christopher Evans was writing a book entitled "20th Century Cults". Legal started writing to him and his publishers and later his lawyers. No proceedings were started because the book had not been published. However, endless letters were sent to and fro over a period of about a year, during which time it was made clear to the publishers and their lawyers that if they published the book, they would have to fight a legal action, which would lose them money.

Finally the publishers lawyers wrote to us to say that there was no point in continuing the correspondence because the publishers had now decided not to publish the book. As of this date, the book has not been published.

3. C. H. Rolph, (small time author and journalist), was commissioned by the NAMH U.K. to write a book on the subject of the NAMH conflict with Scientology, from their viewpoint. PRO got in touch with Rolph - Rolph came down to SH and there were a series of friendly letters. Rolph finally submitted his manuscript to PRO but, in spite of the friendly visits, it turned out that he was just a NAMH hack and had written an attack.

Legal wrote to him and his lawyers, and pointed out that publication would be a contempt of court (because of other legal actions which we have against the NAMH). The book has not been published.

4. "Scientology, what it is - what it does" by Rev. Morris Burrell was the first book published in the UK, solely on the subject of Scientology. Burrell had been in comm with PRO and a long series of letters had passed between them. But once again, the book when published turned out to be hostile. The front cover of the book contained the Scientology double triangle and our first thought was to begin legal proceedings for infringement of trademark. However, on reading the book, it was discovered that Burrell had mentioned a number of libel actions in which I or S was engaged and I commented upon them.

Thus, being a contempt of court, legal moved a court for an order "that Morris C. Burrell do stand committed to Her Majesty's Prison at Brixton and that the publishers may be so committed for their several and respective misdeeds".

So, legal took them to Court, and the Judge found at the book was a contempt of court. So the book was withdrawn from publication without any copies having been sold to the public.

The latest book is by Cyril Vosper called "The Mindbenders", stupid bit of matter. A preview of the book was sent out to the publishers, and PRO was alerted by a phone call from TV station, who wanted a confrontation on TV with Cyril Vosper. This gave the G.O. 24 hours to stop the book, the confrontation and attendant bad publicity.

The book contained numerous quotes from Scientology books and policy letters etc and contained some data which Vosper had learned on the Solo Course. Legal proceedings were brought on the basis of breach of copyright and breach of confidential relationship (meaning putting in details of the Solo Course). As time was short, B4 did a superb job of getting data, PRO did a superb job of stalling TV, and Legal went round to the Judge in the evening at his own home, to ask for an injunction. (An injunction is a Court order stopping a person from doing a particular act). In this case the injunction was to prevent the book from being sold or distributed. PRO went down to the TV station, to be ready to appear, in case the injunction was not obtained. The programme announcer had already made his introductions on Cyril and his book, when the phone rang in the studio, and our lawyer informed the producer that the injunction had been obtained. The announcer was forced to apologize to the viewers, and PRO handled the resultant tension after the programme had not gone on, with a drunken Vosper and furious producer.

The injunction was Ex parte (the other side was not present when it was obtained) and 3 weeks later legal went before the Court again for a contested hearing, to see whether the injunction should be continued or not. Legal won on both counts of copyright and breach of confidence. The other side now have 14 days in which to appeal.

The point of relating these actions is to indicate that the following countries have similar laws to Britain:

New Zealand

Australia

South Africa

Canada

There is no acceptable justification in these countries for no action being taken against the publishers or authors of entheos Books. The G.O. has to act fast, effectively and with imagination. The skill required is in

- 1) Having the brains to see a possible course of action, no matter how unlikely.
 - 2) Having the necessary organisation to start that action immediately and bring it to a point of decision and decision.
- (The longer the delay, the greater the chance of failure).

Legal U.K. seldom, if ever, assesses its chances of winning before commencing action. Its ability lies in getting the action into court fast, without a Q&A on the chances of winning. No-one can accurately assess in advance the chances of winning or losing, as this is a matter of individual lawyers, individual judges, how many are breaks the judge had that day, the particular circumstance of the particular case which strikes the Judge and good fortune. Good fortune never strikes you in Court, unless you are in Court.

- 4) Legal U.K. has been in courts more often in the past 3 years than the rest of the Scientology world combined. They have won more cases and lost more cases than anywhere else. They lost cases they were sure they would win, and won cases they were sure they would lose. The losses did not hurt us, and the successes established an iron clad ethics presence, which has probably prevented more enatheta than we will ever know about (B4 feedback lines confirm this).
- 5) Do not worry about whether you will win or lose, but direct all effort and concentration on the legal technicalities required to achieve a legal confrontation.
- 6) It is always technically possible - though sometimes difficult, to get into Court. The most difficult part is in forcing your legal team, especially outside lawyers, to get this done, in spite of their terror of losing. It requires intention, determination and forceful persistence to get this done. Not legal genius.

Re USA

In America, where Freedom of Speech includes freedom to malign with impunity, except for old ladies and crippled men, much more imagination is required. Because of the Constitution of America, and case law on libel, inclusive of recent Supreme Court decisions, it is impossible to prevent publication of libel. Attempts to prevent a book being published are called pre-publication censorship, and are extremely unpopular legally. However, where U.S. legal has been successful is prior to Court appearances and actual trial in effecting settlement.

The button used in effecting settlement is purely financial. In other words, it is more costly to continue the legal action than to settle in some fashion. Using this, legal U.S. usually moves for retraction of the libel and/or publication of a correction or Scientology viewpoint.

Therefore, it is imperative that legal US Dev-T his opponents and their lawyers with correspondence (a lawyer's letter costs approx \$50), phone calls (time costs), interrogatories, depositions and whatever else legal can mock up.

One of the bright spots of US legal is that even if you lose you don't pay your opponent for his lawyers fees. Therefore the cost of any legal action is small by comparison with Commonwealth Countries, where the loser pays everything.

M.B.: Any legal action on enatheta publications needs the co-ordination of PR, Legal and B4. One should not be afraid of being afraid of being afraid. The reputation that we are the laws of

the Country to uphold our legal and civil rights.

EUROPE

Legal terminals have only just been set up and although the laws are different from Commonwealth and US laws, there are actions which can be taken if they are researched and forced through.

Up to this point, the G.O. has been entirely swayed by our lawyers negative opinions but legal in Europe should note the message in this Guardian order.

The message is that in combatting unethical articles and books, legal should be aggressive, fast, persistent and untiring.

Every skirmish should be treated like a major battle.

OBSERVATIONS ON THE GREAT HEALTH MONOPOLY.

The course of any monopoly or attempted monopoly in any field is similar.

Those attempting the monopoly, whether they have a product or subject or not, edge their way from obscurity into greater and greater dominance in their field by eliminating rivals, potential rivals and those they think are or might become rivals.

Using various means - black PR, capital, media control, real or false promises and other means - they come to a position where they are big enough to invite or use or subvert government co-operation.

Continuing their goal of monopoly they then more and more utilise government to maintain its gains and enlarge them.

Eventually the monopoly is being maintained at tax payer expense.

The excuses invented as to why this course must be followed and the "public necessity" of the monopoly are many and varied.

The Great Health Monopoly has followed this course and has even begun to spend US taxpayer sums similar to the Defense Budget. It has defended itself so well with excuses of "public necessity" that it has even defied the US Congress and has flouted all and every anti-trust law.

The Great Health Monopoly is linked by the AMA requirements that psychiatrists be MDs, that the psychologists and now even chiropractors all share the mantle. By directorates and other ways drug firms are also linked. This monopoly IS a monopoly, no matter what reasons of "public necessity" it may have. And it is behaving like a Monopoly.

The case history recently accumulated re Chiropractors, who, harrassed for decades, are now part of the monopoly is a vital piece of evidence.

But the Great Health Monopoly has one flaw. It is NOT delivering health. And the cost of what it does say it delivers is beyond belief. It is NOT popular.

Laws exist against monopolies. The anti-trust laws of the US are very severe. The Common Market has anti-monopoly regulations, so much so that England's laws which favour monopoly are said to be scheduled for change as part of her entree program.

The Great Health Monopoly has so PR'd the vast dangers of "unqualified persons" and "abuses" that people seem convinced it is all very usual and that they are just public benefactors.

As this Monopoly is also International (as the part played by the WHO and NAMH show) is also witnessed by the control exerted by it over Health Ministers.

It does not differ from any other monopoly. Its pretences that seek to excuse it are false. It is not delivering services required and is even limiting those which exist while greatly increasing price.

It cannot produce a stable RESULT and does not even in the field of the mind.

It has sought to reduce all things spiritual and mental to a physical and drug base. It is sufficiently greedy that it has attempted to crush every single possible opponent.

Although it may seem a very large task, it is open to attack through anti-trust and anti-monopoly laws.

It is NOT admired by the public. It has not yet totally wrapped up Europe. It is NOT delivering. It IS increasing costs and it IS limiting service.

Its pretense of "public necessity" can be exploded.

Once TV stations thought they owned the air. A concerted grass roots action has all but destroyed these fancied rights. The hole that was attacked was Federal Licensing renewal.

Some such hole as this must exist in the Great Health Monopoly. Such as the "rights" of the AMA to limit or regulate who can train doctors. There must be other such holes.

Until this Monopoly is cowed and disintegrated, there will be no health for this planet, no end of its crime and no chance for those it fancies, no matter how mistakenly, stand in its road.

It would seem upon examination that breaking this monopoly is the best long range chance of survival.

And it is a matter of record that grass roots groups have successfully challenged and broken very firm and very vocal monopolies.

Anti monopoly sentiment; anti-special rights public opinion are now very strong.

A monopoly that cannot deliver is very susceptible to being broken. Especially by those who can.

Ref. of successful action: United Church of Christ vs Jackson, Miss station WLET-TV via FCC and Wash. DC Court of Appeals. Everett Parker, director of OFFICE OF COMMUNICATIONS of the UNITED CHURCH OF CHRIST assisted by Earl K (Dick) Moore, a Wall Street attorney, forced a new licensee to be found for WLET-TV. It was giving black PR to civil rights. The FCC did not co-operate with the Church but was forced to by the courts. This broke down the whole chain or "permanent licensing" by negating automatic renewal. Other groups have brought other stations to heel. TV now plays it very carefully. It no longer black PRs. So a small group can force a monopoly (of a channel) breakage. State licensing or other monopolistic or some monopolistic abuse by any portion of the Great Health Monopoly on a basis of no-service or public interest can be found, probably innumerable ones can be found, that would force the anti-trust authorities to act by bringing action through petition and then enforcing the petition via court action. In short, a route has been pioneered to force a government to act to break down a monopoly and make monopolists be very very careful.
